Amendment to Regulations under the Motor-vehicles Act, 1924, as to the Equipment and Use of Motor-vehicles, as to Notices and Signs, and generally as to Motor-traffic.

In pursuance and in exercise of the powers conferred on him by the Motor-vehicles Act, 1924, and of all other powers enabling him in that behalf, His Excellency the Governor-General of the Dominion of New Zealand, acting by and with the advice and consent of the Executive Council of the Executiv of the said Dominion, doth hereby make the following regulations in amendment of the Motor-vehicle Regulations, 1933 (hereinafter termed the "said regulations").

# REGULATIONS.

1. These regulations may be cited as the Motor-vehicle Regulations, Amendment Number 1.

2. (1) While a motor-vehicle used by a fire brigade for attendance at fires (hereinafter termed a "fire-engine") is responding to an alarm of fire it shall be exempted from the requirements of Regulation 11, clauses (12) and (13), and Regulation 15, clause (3), of the said regulations.

(2) A fire-engine may be fitted near its longitudinal centreline and at a height of not less than 3 ft. 6 in. from the ground with a larm canable of displaying a red light to the front of

with a lamp capable of displaying a red light to the front of not less than 6 in. in diameter. The said light shall be dis-played only while the vehicle is responding to an alarm of

ire.

3. (1) Paragraph (b) of the definition of "independent brake" in clause (1) of Regulation 4 of the said regulations is hereby revoked and the following submitted therefor:—

"(b) Common to any other brake or brake system only in parts or connections which are of such design and strength that under normal operating conditions and with a proper standard of maintenance there is no reasonable probability of failure of the independent brake by reason of the failure of any other brake or brake system."

(2) The said Regulation 4 is hereby further amended,—

(a) As to clause (3) by revoking the words "other than a private motor-car";

(b) By revoking clause (4) thereof.

4. In regard to the main highways or sections of main highways described in the Schedule hereto, clause (2) of Regulation 15 of the said regulations shall apply as if for the word "forty" therein were substituted the words "forty-five."
