Writs for Service or Commissions to take Evidence in Foreign Countries in Civil and Commercial Matters.

MEMORANDUM AS TO THE CHANNEL BY WHICH WRITS FOR EMORANDUM AS TO THE CHANNEL BY WHICH WRITE FOR SERVICE OR COMMISSIONS TO TAKE EVIDENCE IN FOREIGN COUNTRIES IN CIVIL AND COMMERCIAL MATTERS EMANATING FROM THE COURTS OF SCOTLAND, NORTHERN IRELAND, AND THE BRITISH DOMINIONS AND COLONIES, ETC., SHOULD REACH THE COMPETENT AUTHORITIES OF THE FOREIGN COUNTRY CONCERNED OR THE BRITISH CONSULAR OFFICERS AS THE CASE MAY BE.

(Paragraphs (a) and (c) have been omitted as they do not 'concern New Zealand.)

(b) Documents emanating from the Courts in the Dominions.

There is at present no settled procedure as to the channel by which writs for service or commissions or requests to take by which writs for service or commissions or requests to take evidence in civil and commercial matters in foreign countries, which emanate from the Courts in the Dominions, should reach the competent authorities of the foreign country concerned or the appropriate diplomatic or Consular officer of His Majesty, as the case may be. It is accordingly proposed to adopt the following procedure:

(1) Cases which fall to be dealt with in accordance with the provisions of a Civil Procedure Convention with the foreign country concerned (i.e., where the Dominion in

foreign country concerned (i.e., where the Dominion in question has acceded to a convention).
