NEW ZEALAND.—SOUTH ISLAND.—BLUFF HARBOUR.

*Leading-marks for Vessels berthing at Ferry Wharf.*

VESSELS intending to berth at the Ferry Wharf should, after passing the light-vessel, approach the berth on or north of the line (265°) with the old Freezer Chimney in transit with the corner (painted black, and white diagonal striped) of the shed on the Ferry Wharf until the vessel's stern is above the east end of the Ferry Wharf.

This leads through in not less than 21 ft. M.L.O.S.
