

Regulations under the Health Art, 1920, as to Quarantine .--(H.H. 124.)

BLEDISLOE, Governor-General. ORDER IN COUNCIL.

At the Government House at Wellington, this 30th day of October, 1933.

Present :

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL. IN PROBLEMOY THE GOVERNOR-GENERAL IN COUNCIL. IN pursuance and exercise of the powers conferred on him by section one hundred and thirty-two of the Health Act, 1920, His Excellency the Governor-General of the Dominion of New Zealand, acting by and with the advice and consent of the Executive Council of the said Dominion, doth hereby make the following regulations in amendment of the Quarantine Regulations, 1921 (hereinafter referred to as "the said regulations"), made by Order in Council on the fourteenth day of November, one thousand nine hundred the fourteenth day of November, one thousand nine hundred and twenty-one, and published in the *Gazette* on the seven-teenth day of the same month, at page 2751, and doth hereby declare that this Order in Council shall come into force on the first day of January, one thousand nine hundred and thirty-four.

REGULATIONS.

1. REGULATION 4 of the said regulations is hereby revoked and the following substituted :-

4. The master of every ship liable to quarantine shall hoist the appropriate signal before the ship comes within one league of any port at which she is about to call and shall ep such signal so hoisted until pratique is granted or the ship is released from quarantine, that is to say :-

IN pursuance and exercise of the powers vested in me by section one hundred and thirty-five of the Public Works Act, 1928, and of all other powers and authorities in anywise enabling me in this behalf, I, Charles, Baron Bledisloe, Governor-General of the Dominion of New Zealand, do hereby authorize the Patangata County Council to construct the bridge (together with approaches thereto) described in the Schedule hereto; and I do also declare that the cost thereof, less such contribution (if any) as may be made thereto by the Government of New Zealand or the Main Highways Board, shall be borne by the Patangata County Council, the Waipawa County Council, the Waipukurau Borough Council, and the Waipukurau County Council in the following Council, and the Waipukurau County Council in the following proportions—viz., the Patangata County Council shall pay twenty-seven and one-half (27 $\frac{1}{2}$) per centum, the Waipawa County Council shall pay thirty (30) per centum, the Wai-pukurau Borough Council shall pay twenty-five (25) per centum, and the Waipukurau County Council shall pay seventeen and one-half (17 $\frac{1}{2}$) per centum of such cost respec-tively; and I do further direct that any contribution hereby required to be made as aforesaid by the Waipawa County

Council, the Waipukurau Borough Council, and the Waipukurau County Council shall be paid from time to time, in the proportion hereinbefore prescribed, out of the funds of the said Councils within a period of one month after demand in writing made by or on behalf of the Patangata County Council, and all such payments shall be made from time to time to the Clerk of the Patangata County Council for and on behalf of the said Councils: And I do hereby revoke the Warrant dated the fifth day of

April, one thousand nine hundred and thirty, and published in New Zealand Gazette No. 27 of the tenth day of the same a bridge over the Tukituki River, on the Wellington-Napier via Wairarapa Main Highway (together with approaches thereto), and apportioning the cost.

Exempting Crown Lands from certain Provisions of the Mining Act. 1926.

BLEDISLOE, Governor-General.

WHEREAS by section twenty of the Mining Act, 1926, W it is, *inter alia*, enacted that the Governor-General may from time to time, by notice in the *Gazette*, exempt any Crown lands from mining, or from any specified mining purpose, or from that Act, or any specified provisions of that Act, and that the lands to which any such notice relates

Any one of the following persons is held to be duly qualified: (a) Members and late members of the Nobel Committee of the Norwegian Parliament, as well as the advisers appointed at the Norwegian Nobel Institute; (b) Members of Parliament and Members of the Institute; (b) Members of Parliament and Members of the Interparliamentary Union; (c) Members of the International Arbitration Court at The Hague; (d) Members of the Commission of the Permanent International Peace Bureau; (e) Members and Associates of the Institute of International Law; (f) University Professors of Political Science and of Law, of History, and of Philosophy; and (g) persons who have received the Nobel Peace Prize. The Nobel Peace Prize may also be accorded to institutions or associations.
