Open Seasons for Imported and/or Native Game in certain Acclimatization Districts.

IN exercise of the powers vested in me by the Animals Protection and Game Act, 1921–22, I, James Alexander Young, Minister of Internal Affairs of the Dominion of New Zealand, do hereby amend the Warrant dated 9th March, 1934, made under the Animals Protection and Game Act, 1921–22, and published in New Zealand Gazette No. 14 of the 12th idem., at page 520, by deleting all that portion of such Warrant included under the headings "Bay of Islands, Feilding and District, Marlborough, Nelson, North Canter-bury, Otago, and Taranaki Acclimatization Districts," and do hereby revoke the Warrant dated 19th day of March, 1934, and published in the New Zealand Gazette of the 22nd day of March, 1934, No. 17, at page 678, declaring an open season for imported and native game in the Wellington Acclimatiza-tion District, and do hereby declare open seasons for imported game and/or native game, of the kinds hereinafter specified, game and/or native game, of the kinds hereinafter specified, in the acclimatization districts specified hereunder, except in the areas shown under the heading "Excepted Areas," during the periods set forth in connection with each district, subject in all cases to the following general conditions and subject In all cases to the following general conditions and subject to the special conditions specified in connection with each district. Any person taking or killing any imported game or native game otherwise than in terms of this notification (including the general conditions hereinafter set out and the special conditions specified in connection with any acclimati-zation district), is liable on conviction to a fine of ± 20 .

GENERAL CONDITIONS.

1. No person shall commence shooting earlier than one hour before sunrise or continue shooting later than one hour after sunset on any day during the open season concerned.

2. No person shall use live birds of any species as decoys nor use artificial decoys so that more than fifteen artificial decoys are used at any one time (whether by one or several persons) on any particular water within an area of less than 100 yards square.

3. No person shall use or cause to be used any motor-vehicle in connection with the taking or killing of imported game and/or native game: Provided that this condition shall not be so construed as to prohibit the use of any motor-vehicle for the purpose of travelling either generally or to

or from a rendezvous. 4. No person shall use or cause to be used for the purpose for taking or killing any imported or native game any unmoored floating stand, pontoon, hide, maimai, or loo, or any boat artificially dressed or covered in any way.

5. No person engaged in shooting from any shelter, maimai, mud-hole, boat, louvre, or other contrivance shall have or use more than one gun.

BAY OF ISLANDS ACCLIMATIZATION DISTRICT.

(As described in New Zealand Gazette No. 17, of 12th March, 1925, at page 749.)

1. Season for cock pheasants, Californian quail, Australian Deason for godwit: 1st February to 31st March, 1935

(inclusive).

3. Licenses to take or kill such imported game and native game (including godwits) within the Bay of Islands Acclima-tization District will be issued to any person on payment of the sum of twenty shillings (20s.) each : and licenses to take or kill the following native game only-viz., godwits-will be issued to any person on payment of the sum of ten shillings (10s.) each; and the Secretary of the Bay of Islands Acclima-tization Society, or any person authorized by such Secretary in that behalf, is hereby authorized to sign and issue the said licenses.

No person shall in any one day take or kill more than ten head of cock pheasants or more than twenty head in all of Californian and Australian quail, or more than twenty head in all of grey duck, black teal, and black swan, or more than fifteen head in all of grey duck and black teal, or take or kill more than twenty head of godwits.

Season for cock pheasants (except in the area bounded on the north by Junction Road, on the east by Makino Road, on the south by Mangone Road, and on the west by Stanway on the south by Mangone Road, and on the west by Stahway Road), and for Californian quail and Australian quail: 1st May to 31st July, 1934 (both days inclusive).
2. Season for mallard duck, grey duck, and black swan: 1st May to 30th June, 1934 (both days inclusive).
3. Licenses to take or kill such imported game and native

game within the Feilding and District Acclimatization District will be issued to any person on payment of the sum of twenty shillings (20s.) each; and the Secretary of the Feilding and District Acclimatization Society, or any person authorized by such Secretary in that behalf, is hereby authorized to sign and issue the said licenses

4. No person shall in any one day take or kill imported game exceeding in number twenty-five head in all of cock pheasants, Californian quail, and Australian quail, or take or kill more than twenty-five head in all of grey duck, mallard duck, and black swan, or take or kill more than ten head of grey duck and/or mallard duck.

MARLBOROUGH ACCLIMATIZATION DISTRICT.

(As described in New Zealand Gazette No. 17, of 12th March, 1925, at page 751.)

Season for grey duck, spoonbill duck, and black swan: 1st May to 30th June, 1934 (both days inclusive).
 Season for Californian quail: 1st May to 31st July, 1000 July

1934 (both days inclusive).3. Licenses to take or kill such imported game and native game within the Marlborough Acclimatization District will be issued to any person on payment of the sum of twenty shillings (20s.) each; and the Secretary of the Marlborough Acclimatization Society, or any person authorized by such Secretary in that behalf, is hereby authorized to sign and issue the said licenses.

4. No person shall in any one day take or kill more than twenty-five head of Californian quail, or take or kill more than twenty-five head in all of grey duck, spoonbill duck, and black swan, or take or kill more than fifteen head in all of grey duck and spoonbill duck, or take or kill more than ten head of grey duck.

NELSON ACCLIMATIZATION DISTRICT.

(As described in New Zealand Gazette No. 17, of 12th March, 1925, at page 751.)

1. Season for grey duck : 1st May to 30th June, 1934 (both days inclusive).

2. Season for Californian quail: 1st May to 31st July, 1934 (both days inclusive).

3. Season for black swan (only in areas included in County of Collingwood, comprising the tidal flats extending from the lighthouse at Cape Farewell along the northern shores of Golden Bay to Puponga): 1st May to 30th June, 1934 (both days inclusive).

4. Season for godwits : 1st February to 31st March, 1935 (both days inclusive).

5. Licenses to take or kill such imported game and native game (including godwits) within the Nelson Acclimatization District will be issued to any person on payment of the sum of twenty shillings (20s.) each, and the Chief Postmaster at Nelson and the Postmasters at Motueka, Motupiko, Wakefield, Murchison, and Reefton are hereby authorized to sign and issue the said licenses, and licenses to take or kill such native game only (viz., godwits) will be issued to any person on payment of the sum of ten shillings (10s.) each; and the Chief Postmaster at Nelson and the Postmasters at Motueka, Takaka, and Collingwood are hereby authorized to sign and issue the said license

6. No person shall in any one day take or kill more than twenty head of Californian quail, or take or kill more than five head of black swan, or take or kill more than ten head of grey duck, or take or kill more than twenty head of godwits. 7. Nothing herein shall apply to Californian quail in the County of Murchison in which county protection has been removed from Colifornian quail

removed from Californian quail.

8. Excepted areas wherein imported game and/or native game shall not be taken or killed during the open season :-(1) Lake Rotoiti.

(2) The Waimea Electric Co.'s two dams on the Wairoa River at Brightwater. (3) Lake Matiri.

NORTH CANTERBURY ACCLIMATIZATION DISTRICT. (As described in New Zealand Gazette No. 68, of 28th September, 1933, at page 2463.)

 Season for mallard duck, grey duck, spoonbill duck, and black swan : 1st May to 30th June, 1934 (both days inclusive).
 Season for Californian quail : 1st May to 31st July, 1934 (both days inclusive).

3. Season for paradise duck : 1st May to 7th May, 1934 (both days inclusive). 4. Season for godwit: 1st February to 31st March, 1935

(both days inclusive).

5. Licenses to take or kill such imported game and native o. Lacenses to take of Kill such imported game and native game, including godwits, within the North Canterbury Acclimatization District will be issued to any person on payment of the sum of twenty shillings (20s.) each; and licenses to take or kill the following native game—viz., grey duck, spoonbill duck (or shoveller), paradise duck, and black swan—will be issued to any person on payment of ten shillings (10s.) each : and licenses to take or kill the following native game—viz., godwits—will be issued to any person on payment game—viz., gouwits—will be issued to any person on payment of ten shillings (10s.) each; and the Secretary of the North Canterbury Acclimatization Society, or any person authorized by such Secretary in that behalf, is hereby authorized to sign and issue the said licenses.

6. No person shall in any one day take or kill more than fifteen head of Californian quail, or take or kill more than five head of paradise duck, or take or kill more than ten head of grey duck or more than ten head of spoonbill duck or more than ten head of mallard duck: Provided that not more than fifteen head in all of grey duck, paradise duck, and spoonbill duck may be taken or killed by any one person in any one day, or take or kill more than fifteen head of black swan or take or kill more than twenty head of godwit. 7. No device or structure other than a hut made of scrub

or rushes or a mud-hole or a mai-mai shall be used from or out of which native game may be taken or killed on or near Lake Ellesmere

8. A mud-hole shall be constructed solely by means of the excavation of the soil, and no timber, metal, or other material

shall be used in the construction thereof. 9. No hut, mud-hole, or mai-mai shall be used in any part of Lake Ellesmere in which the water is of a greater depth than twenty-four inches. 10. Notwithstanding anything contained in conditions 6 to 8

hereof, a boat concealed among the vegetation growing along or near the margin of Lake Ellesmere may be used for the purpose of taking or killing native game on or near such lake, or such boat may be used for the purpose of recovering native game which has been shot (provided that no boat so

4. Licenses to take or kill such imported game and native game, including godwits, within the Otago Acclimatization District will be issued to any person on payment of the sum of twenty shillings (20s.) each, and licenses to take or kill such

twenty shillings (20s.) each, and licenses to take or kill such native game only, including godwits, will be issued to any person on payment of the sum of ten shillings (10s.) each; and the Secretary of the Otago Acclimatization Society, or any person authorized by such Secretary in that behalf, is hereby authorized to sign and issue the said licenses. 5. No person shall in any one day take or kill imported game and/or native game exceeding in number twenty head in all of Californian quail, grey duck, and spoonbill duck, or take or kill more than twenty head of Galifornian quail, or take or kill more than fifteen head of grey duck and/or spoonbill duck; or take or kill more than twelve head of mallard duck, or take or kill more than the head of black swan (provided that in estimating the total head of game allowed (provided that in estimating the total head of game allowed to be taken or killed by any one person in any one day black swan shall not be taken into consideration) or take or kill

more than twenty head of godwits. 6. A license issued pursuant to this notification to take or will imported and native game or native game only shall Australian entitle the holder thereof to take or kill native game in the inclusive).

5. No person shall in any one day take or kill more than two head of cock pheasants, or take or kill more than two head of black swan, or take or kill a number exceeding ten head in all of grey duck, mallard duck, and/or shoveller duck.

6. Nothing herein shall apply to hares in the counties of Akitio, Castlepoint, Masterton, Pahiatua, Featherston, and Wairarapa South, wherein these animals are not protected.
