*One Tree Hill Borough Council.—Cancellation of Unexercised Loan Authority.*

In the matter of section 118 of the Local Bodies' Loans Act, 1926.

WHEREAS the One Tree Hill Borough Council has been duly authorized to borrow by way of special loan the sum of twenty-four thousand three hundred and fifty pounds (£24,350) for the construction of portion of the Great South Road, and the consent of the Governor-General in Council to the raising of the said loan was given by Order in Council made on the 16th day of August, 1926, and published in the *Gazette* on the 19th day of the same month, at page 2535:
