Land set apart as an Endowment for Primary Education.

BLEDISLOE, Governor-General. [L.S.] A PROCLAMATION.

In pursuance and exercise of the powers conferred by subsection nine of section twelve of the Land Act, 1924, I, Charles, Baron Bledisloe, Governor-General of the Dominion of New Zealand, do hereby proclaim and declare that from and after the date hereof the land comprised in the pieces of closed road and the land taken for severances described in the First Schedule hereto, being land which is adjacent to the endowment for primary education described in the Second Schedule hereto, shall be deemed to be added to the said endowment.

FIRST SCHEDULE.
