WHEREAS by section four hundred and fifty-four of the Native Land Act, 1931, it is provided, inter alia, that on being satisfied that the purchase of any Native land has been duly completed by or on behalf of the Crown under the authority of the Native Land Act, 1931, the Governor-General may issue a Proclamation that such land has become Crown
