*Classification of Roads in Westland County.*

IN pursuance and exercise of the powers conferred on me by the Transport Department Act, 1929, and the Heavy Motor-vehicle Regulations, 1932, I, Joseph Gordon Coates, Minister of Transport, do hereby alter the Westland County Council's proposed classification and proposed alteration in classification of the roads described in the Schedule hereto and situated in the Westland County, and do hereby approve such classification and altered classification as set forth in the said Schedule.

*Prohibition of Issue of Money-orders and Transmission of Postal Correspondence.*
