DURSUANT to the Public Works Act, 1928, His Excellency the Governor-General of the Dominion of New Zealand, acting by and with the advice and consent of the Executive Council, doth hereby grant to Hector B. Walker a license subject to the conditions hereinafter set forth to obstruct, impound, or divert the waters of an unnamed stream situated in Section 51, Block IV, Inangahua Survey District, and to take and use therefrom for the purposes hereinafter set forth a stream of water not exceeding one cubic foot per second at any one time. any one time.

CONDITIONS.

1. IMPLIED CONDITIONS.

THE conditions directed to be implied in all licenses by the Water-power Regulations, 1934, shall be incorporated in and shall form part of this license, except in so far as the same may be inconsistent with the provisions hereof.

2. Utilization of Water and Location of Headworks. Water shall be used under this license solely for the purpose of generating electricity and shall be taken from the stream at the point in Section 51, Block IV, Inangahua Survey District, indicated on the plan marked P.W.D. 87931, deposited in the office of the Minister of Public Works.

3. GENERAL DESCRIPTION OF WORKS.

The licensee is hereby authorized, subject to the conditions hereof, to construct, maintain, and use the following works for the purposes of this license, the positions of the said works being indicated on the said plan P.W.D. 87931:—

(a) Headworks consisting of an intake and water-race and pipe-lines leading to the water-wheel and powerhouse hereinafter referred to.

(c) A power-house with all necessary equipment, including water turbines, generators, transformers, lightning-arresters, switchboards, switches, exciters, and other appliances for generating electricity.
