A PROCLAMATION.

In pursuance and exercise of the powers and authorities act, 1921–22, I, George Vere Arundell, Viscount Galway, Governor-General of the Dominion of New Zealand, acting on the recommendation of the Minister of Lands, do hereby proclaim and declare that the land described in the Schedule hereto, being portion of a provisional State forest set apart by Proclamation dated the eighteenth day of October, one thousand nine hundred and twenty-one, and gazetted on the twentieth day of that month, as amended by Proclamation thousand nine nundred and twenty-one, and gazetted on the twentieth day of that month, as amended by Proclamation dated the sixth day of February, one thousand nine hundred and twenty-two, and gazetted on the ninth day of that month, is required for settlement purposes; and, in accordance with the provisions of the said Act, such land shall, from and after the day of the gazetting hereof, cease to be provisional State forest, and shall become subject to the provisions of the Land Act, 1924 the Land Act, 1924.
