## TAURANGA ELECTRIC-POWER BOARD.

## RESOLUTION MAKING SPECIAL RATE.

IN pursuance and in exercise of the powers vested in it in that behalf by the Local Bodies' Loans Act, 1926, and of all other powers (if any) it thereunto enabling, the Tauranga Electric-power Board hereby resolves as follows:—

"That, for the purpose of providing for the payment of the principal, interest, and other charges in respect of the Tauranga Electric-power Board Electrical Extension Loan of £40,000 authorized to be raised by the Tauranga Electric-power Board under the above-mentioned Act by a poll of the ratepayers taken on the 28th day of September, 1935, for the purpose of supplying and distributing electrical energy throughout the Board's district, the Board hereby makes and levies a special rate of one penny (1d.) in the pound on the rateable value (on the basis of the unimproved value) of all rateable property in the Tauranga Electric-power District, and that such special rate shall be an annually recurring rate during the currency of such loan and be payable annually on the 1st day of June in each and every year during the currency of such loan, being a period of twenty (20) years or until the loan is fully paid off."

The above resolution was passed at a meeting of the Tauranga Electric-power Board held on the 21st day of May, 1936.
