

*Classification of Roads in Hobson County.*

IN pursuance and exercise of the powers conferred on me by the Transport Department Act, 1929, and the Heavy Motor-vehicle Regulations, 1932, I, Robert Semple, Minister of Transport, do hereby revoke the Warrants described in the First Schedule hereto so far as they relate to the classification of the roads described in the Second Schedule hereto and situated in the Hobson County, and do hereby declare that the said roads shall belong to the class of roads shown in the said Second Schedule.

*Notice of Intention to take Land for the Purposes of a Road in Block III, Waiwera Survey District.*
