doing all possible to eliminate all conditions that detract from the value of skins, it is imperative that rock-damage be obviated as much as possible. While it is realized that in some cases some such damage is unavoidable, much can be done during skinning to prevent further damage, and any seriously damaged skins must not be submitted.
