Proposed Boundaries of the Electoral Districts in the North Island of New Zealand.

THE North Island Representation Commission appointed under the Electoral Act, 1927, in pursuance of section 11 of the said Act, hereby publish for general information the following proposed boundaries of the electoral districts in the North Island; and, further, give notice that written objections to the same will be received by the undersigned, the Chairman of the said Commission, at the office of the Surveyor-General, Wellington, not later than noon on Monday, the 30th day of August, 1937, for consideration by the aforethe 30th day of August, 1937, for consideration by the aforesaid Commission.

Maps of the proposed districts may be seen at the offices of the several local bodies in the said North Island; of the Chief Surveyors at Auckland, New Plymouth, Gisborne, Napier, and Wellington; of the Chief Electoral Officer at Wellington; and of the several Registrars of Electors throughout the North Island aforesaid.

NORTH ISLAND ELECTORAL DISTRICTS. BAY OF ISLANDS.

BAY OF ISLANDS. BAY OF ISLANDS. BAY of Islands District comprises the existing Bay of Islands Electoral District less those portions of the Mangakahia, Wairua, Hikurangi, and Otonga Ridings of the Whangarei County lying to the north of the existing Bay of Islands Electoral District boundary, and to the south of the southern boundary of the Bay of Islands County, also less the Hikurangi Town District.

KAIPARA.

Kaipara District comprises the existing Kaipara Electoral District less the Mairetahi, Kumeu, and Pukeatua Ridings of the Waitemata County, also less that portion of the Takapuna Riding of the aforesaid county lying to the north of the existing Kaipara Electoral District boundary, also less that portion of the Kaukapakapa Riding of the aforesaid Waitemata County lying to the south of the Kaukapakapa River and Kaukapakapa Road, also less the Helensville Town

District. This district now includes that portion of the Mangakahia Riding of the Whangarei County excluded from the Bay of Islands Electoral District hereinbefore described, the Bay of Islands Electoral District hereinbefore described, together with those portions of the Matakana, Kourawhero, and Puhoi Ridings of the Rodney County lying to the east of the existing Kaipara Electoral District boundary, also the Warkworth Town District and those portions of the Wainui and Kaukapakapa Ridings of the Waitemata County lying to the north of the existing Kaipara Electoral District boundary.

MARSDEN.

Marsden District comprises the existing Marsden Electoral Marsden District comprises the existing Marsden Electoral District less the Warkworth Town District and those portions of the Matakana, Kourawhero, and Puhoi Ridings of the Rodney County together with those portions of the Wainui and Kaukapakapa Ridings of the Waitemata County now included in the Kaipara Electoral District hereinbefore described, also less Tiritiri Island. This district now includes those portions of the Wairua, Hikurangi, and Otonga Ridings of the Whangarei County together with the Hikurangi Town District now excluded from the Bay of Islands Electoral District hereinbefore described.

WAITEMATA.

Waitemata District comprises the existing Waitemata Electoral District less the Borough of Devonport. This district now includes the Mairetahi, Kumeu, and Pukeatua Ridings of the Waitemata County together with those portions of the Takapuna and Kaukapakapa Ridings of the aforesaid county excluded from the Kaipara Electoral District herein-before described, also includes the Borough of Birkenhead and the Helpergrille Town District and the Helensville Town District.

AUCKLAND SUBURBS.

Auckland Suburbs District comprises the existing Auckland Suburbs Electoral District less the Borough of Birkenhead now included in the Waitemata Electoral District hereinbefore described. This district now includes that portion of the Borough of Mount Albert lying between the existing Auckland Suburbs Electoral District boundary and the western side of the Woodward and Richardson Roads.

AUCKLAND WEST.

Anckland West District comprises the existing Auckland West Electoral District less the whole of Great Barrier Island County and adjacent islands, also Little Barrier Island. This district now includes that portion of Auckland City lying between the existing Auckland West and Grey Lynn Electoral District boundaries and the western side of Union and Nelson Streets, northern side of Beresford Street, western side of Howe Street, southern side of Karangahape Road, western side of Cobden Street, and northern sides of Montague, Regent, Exeter, and Cecil Streets.

GREY LYNN.

Grey Lynn District comprises the existing Grey Lynn Electoral District less that portion of the Mount Albert Borough lying between the existing Grey Lynn Electoral District boundary and the southern side of Aitken Terrace and eastern side of King Street.

EDEN.

Eden District comprises the existing Eden Electoral District less those portions of the Mount Eden Borough and Auckland City lying between the existing Eden Electoral District boundary and the northern sides of Sylvan Avenue, Wynyard Road, and Brentwood Avenue, and eastern side of Dominion Road. This district now includes that portion of the Mount Albert Borough excluded from the Grey Lynn Directoral District hereinbefore described together with that portion of the Mount Albert Borough lying between the existing Eden and Grey Lynn Electoral District boundaries and the eastern side of Asquith Avenue, northern side of Jesmond Terrace, western side of New North Road, northern side of Salisbury Road, eastern side of Taylor's Road, and northern side of St. Lukes Road. ROSKILL.

Roskill District comprises the existing Roskill Electoral District less those portions of the Mount Albert Borough now included in the Auckland Suburbs and Eden Electoral Districts hereinbefore described, also less that portion of the Onehunga Borough lying between the existing Roskill Electoral District boundary and the western boundary of the said Onehunga Borough.

AUCKLAND CENTRAL.

Auckland Central District comprises the existing Auckland Central Electoral District less that portion of the Auckland City now included in the Auckland West Electoral District hereinbefore described. This district now includes those portions of the Mount Eden Borough and Auckland City excluded from the Eden Electoral District hereinbefore described together with those portions of the Mount Eden Borough and Auckland City lying between the existing Auckland Central Electoral District boundary and the western side of the Strand, southern side of Gittos Street, western side of the road leading to Carlew Park, western side of the said Carlew Park, western side of the Auckland Domain, western side of Seafield View Road, northern side of Carlton Gore Road, western sides of Nugent Street and Grafton Road, southern side of Boston Road, and western side of Normanby Road, also includes Tirtiri and Little Auckland Central District comprises the existing Auckland side of Normanby Road, also includes Tiritiri and Little Barrier Islands.

AUCKLAND EAST.

Auckland East District comprises the existing Auckland Auckland Central Electoral District less those portions of the Mount Albert Borough and Auckland City now included in the Auckland Central Electoral District hereinbefore described. This district now includes the Borough of Devonport.

REMUERA.

Remuera District comprises the existing Parnell Electoral District less that portion of the One Tree Hill Borough lying between the existing Parnell Electoral District boundary and the southern side of Ranfurly Road, western side of Market Road, southern side of Wapiti Avenue, southern side of Wheturangi Road, eastern side of Arotonga Avenue, and the southern side of the Cast Sacting Data the southern and southern side of the Great South Road; as less those portions of the Ellerslie Town District lying between the existing Parnell Electoral District boundary and the southern side of the Auckland City boundary. This district now side of the Auckland City boundary. This district now includes those portions of Auckland City lying between the existing Parnell Electoral District boundary and the Auck-land City boundary on the northern boundary of the Ellerslie Town District.

ONEHUNGA.

Onehunga District is bounded on the north generally by the Roskill, Eden, and Remuera Electoral Districts herein-before described from St. Andrew's Road to the Great South Road; thence bounded towards the east generally by the eastern boundary of the One Tree Hill Borough from the Great South Road to Manukau Harbour; thence bounded towards the south generally by the northern shores of the said Manukau Harbour from the eastern boundary of the said One Tree Hill Borough to the western boundary of the Onehunga Borough; thence bounded towards the west generally by the western boundary of the said Onehunga Borough and the Roskill Electoral District from Hillsborough Bay to St. Andrew's Road, the place of commencement.

OTAHUHU.

Otahuhu District is bounded towards the north generally by the Onehunga and Remuera Electoral Districts herein-before described from the eastern boundary of the One Tree Hill Borough at Manukau Harbour to the Tamaki River at the Auckland City boundary; thence by the said Tamaki River and the southern shores of the Tamaki Strait to the mouth of the Wairoa River; thence bounded towards the east generally by the said Wairoa River to its intersection with the southern boundary of Manukau County; thence bounded towards the south generally by the southern boundary of the said Manukau County and the existing boundary of the Franklin Electoral District to the mouth of the Puhinui Creek; thence bounded towards the west generally by the eastern shores of the said Manukau Harbour from the mouth One Tree Hill Borough, the place of commencement.

FRANKLIN.

Franklin District comprises the existing Franklin Electoral District, the boundaries of which are unaltered.

HAMILTON.

Hamilton District comprises the existing Hamilton Electoral District less that portion of the Rototuna Riding of Waikato County lying between the existing Hamilton Electoral District boundary, the Waikato River, and the roads bounded by Sections 42, 55, 56, 57, Lots 3 and 2, Sections 60, 65, 63, 139, 135, and Lots 6, 5, and 4 of Blocks IX and X, Komakorau Survey District, and the Puketaha Road, also less that portion of the Hamilton Riding of the Waipa County lying between the existing Hamilton Electoral District boundary, the Waikato River, the south-eastern boundaries of Lot 1, part Lot 7, D.P. 13101, part Lot 7, D.P. 5041, and D.P. 11955, to and along the road fronting Lots 5 and 4, D.P. 5041, to and along the road intersecting Section 41A and its production, to and along the road fronting Sections 41 and 43A and its continuation, to and along the road forming the north-eastern boundary of Section 73, to and along the road forming the north-western boundaries of Sections 77, 78, 79, 79A, 81, and 82, all of Block XIII, Komakorau Survey District, and Block I, Hamilton Survey District; also less that portion of the Rukuhia Riding of the aforesaid Waipa County lying between the existing Hamilton Electoral District boundary and the roads intersecting Section 32 and forming the southern boundaries of Sections 30, 48, 42, 43, 44A, 44, 57, 75, 76, 78B, and 79B, all of Blocks I and II, Hamilton Survey District.

RAGLAN.

Raglan District comprises the existing Raglan Electoral District less the whole of the Pukekura, Rangiaohia, Kaipaki, and Mangapiko Ridings of the Waipa County. This district now includes that portion of the Rototuna Riding of Waikato County, also those portions of the Hamilton and Rukuhia Ridings of the Waipa County now excluded from the Hamilton Electoral District hereinbefore described.

HAURAKI.

HAURARI. Hauraki District is bounded towards the north generally by the shores of the Tamaki Strait and the Firth of Thames from the mouth of the Wairoa River to the mouth of the Waihou River; thence bounded towards the east generally by the said Waihou River to the railway-line at Te Aroha Borough; thence bounded towards the south generally by the said railway-line and the Te Aroha – Morrinsville Road to Thomas Road, and by that road to the Waitoa River, and by that river to the Te Aroha – Morrinsville Road, and by that road to and along the eastern and southern boundaries of the Morrinsville Riding of Piako County, to and along the southern and western boundaries of the Morrinsville Brough. to and along the Auckland – Te Aroha Railway line, to and along the Auckland – Te Aroha Railway line, to and along the road intersecting Lots 1, 3, and 8, and forming eastern boundary of Lot 4, Eureka Estate, and road forming eastern boundaries of Lots 9 and 8, Newstead Estate, all of Blocks XII and XVI, Komakorau Survey District, to and along the southern boundary of Ruakura Riding to the Hamilton Electoral District boundary hereinbefore described; thence bounded towards the west generally by the Hamilton, Raglan, Franklin, and Otahuhu Electoral Districts boundaries hereinbefore described to the mouth of the Wairoa River, the place of commencement.

THAMES.

Thames District comprises the existing Thames Electoral District less that portion of the Hauraki Plains County lying between the existing Thames Electoral District boundary and the Waikato River now included in the Hauraki Electoral District hereinbefore described. This district now includes Great Barrier Island County, the Borough of Te Aroha, and the Mangaiti Riding of Ohinemuri County.

TAURANGA.

Tauranga District comprises the existing Tauranga Electoral District less the Borough of Te Aroha and the Mangaiti Riding of Ohinemuri County now included in the Thames Electoral District hereinbefore described; also less the Te Aroha and Manawaru Ridings of Tauranga County; also less the Rangitaiki; Omataroa, Nukuhou, and those parts of the Waimana, Opouriao, and Taneatua Ridings of the Whaka-tane County leing hotmoon the criting Tauranga Electoral bar County lying between the existing Tauranga Electoral District boundary and the western boundary of the said Rangitaiki Riding of the said Whakatane County. This district now includes the Borough of Matamata, the whole of Waharoa and Matamata Ridings of Matamata County, and that part of the Te Poi Riding of the said Matamata County the said Matamata County, and that part of the Te Pol Kiding of the said Matamata County lying between the northern boundary of the aforesaid Te Poi Riding, the Waihou River, the Kaimai Main Highway, No Name Road, and the Raparapa Road to and along the south-eastern boundary of the Provisional State Forest Reserve, also includes that portion of the Provisional State for the aforesaid Matamata County lying to the north of Lot 1, D.P. 17740, Block I, Tapapa Survey District, Morgan's Road, eastern side of Matai Road, and northern side of Puketutu Road.

WAIKATO.

This district is bounded towards the north-west and east generally by the Raglan, Hamilton, Hauraki, Thames, and Tauranga Electoral Districts boundaries hereinbefore described fairing a Electoral Districts boundaries hereinbefore described from the Waipa River at the southern boundary of Raglan County to the Mangapapa River at the westernmost corner of Lot 1, D.P. 17740, Block I, Tapapa Survey District; thence by the northern boundaries of Taotaoroa and Maungatautari Bidmore of the main Michael County, to and along the eastern boundaries of Taotaoroa and Maungatautari Ridings of the said Matamata County, to and along the western boundary of the aforesaid Matamata County, to and along the northern boundary of the Orakau Riding of Waipa County, to and along the eastern and southern boundaries of the Borough of Te Awamutu, to and along the southern boundary of the Mangapiko Riding of the said Waipa County to the Waipa River, the place of commencement.

WAITOMO.

Waitomo District comprises the existing Waitomo Electoral District less that portion of the Waimiha Riding of Tau-marunui County lying between the existing Waitomo Electoral District boundary and the northern boundary of the said Taumarunui County; also less that portion of the Matiere Riding of Ohura County juing between the existing Waitomo Electoral District boundary and the northern boundary of the said Ohura County; also less the Borough of Te Awamutu. This district now includes those portions of the Waipa and Wharepapa Ridings of Otorohanga County lying between the existing Waitomo Electoral District boundary and the eastern boundary of the said Otorohanga County.

ROTORUA.

Rotorua District comprises the existing Rotorua Electoral District less the Borough of Matamata, the Walton Riding of Piako County, the Taotaoroa and Maungatautari Ridings of Matamata County; also less the Waharoa and Matamata Matamata County; also less the Waharoa and Matamata Ridings and those parts of the Te Poi and Peria Ridings of the said Matamata County now included in the Tauranga Electoral District hereinbefore described; also less that portion of the Waimana Riding of Whakatane County lying between the existing Rotorua Electoral District boundary, the Rotorua-Wairoa Road, and the Gisborne Land District boundary. This district now includes that portion of the Tauroe County Lying between the avisiting Rotorua Fleetoral the Kotorua-warroa road, and the Chevran Line -----boundary. This district now includes that portion of the Taupo County lying between the existing Rotorua Electoral District boundary and the southern and western boundaries of the said Taupo County; also includes that portion of the Pungapunga Riding of Taumarunui County lying between the existing Rotorua Electoral District boundary and the contemponent southern and western boundaries of the said Taueastern, southern, and western boundaries of the said Tau-marunui County.

BAY OF PLENTY.

Bay of Plenty comprises the existing Bay of Plenty Electoral District less the whole of the Tiniroto, Te Aroha, and Patutahi Ridings of Cook County ; also less that portion of the Ngatapa Riding of Cook County lying between the existing Bay of Plenty Electoral District boundary, the Wharekopae Stream, and the road intersecting Wharekopae IB 2 Block, intersecting Section 2, and forming western boundary of Section 5, Block V, Ngatapa Survey District. This district now includes the Rangitaiki, Omataroa, Nukuhou, and those parts of the Waimana, Opouriao, and Taneatua Ridings of the Whakatane County now excluded from the Tauranga Electoral District hereinbefore described.

GISBORNE.

This district is bounded towards the north generally by the This district is bounded towards the north generally by the Rotorua and Bay of Plenty Electoral Districts hereinbefore described from the Rotorua–Wairoa Road to the sea; thence towards the east and south by the sea to the Wairoa Borough boundary at the mouth of the Wairoa River; thence bounded towards the west generally by the eastern and northern boundaries of the said Wairoa Borough to the said Wairoa River; thence by the said Wairoa and Waikare Teheke Rivers to and along the said Wairoa Poed on the centern to and along the said Rotorua–Wairoa Road on the eastern shores of Lake Waikaremoana to the Rotorua Electoral District boundary, the place of commencement.

NAPTER.

Napier District comprises the existing Napier Electoral District together with that portion of the Petane Riding of Hawke's Bay County lying between the existing Napier and Hawke's Bay Electoral District boundaries, the Esk River, and the Hedgeley-Seafield and Wharerangi Roads.

HAWKE'S BAY.

This district is bounded towards the north generally by the Rotorua and Gisborne Electoral Districts hereinbefore described from the Ngaruroro River to the mouth of the Wairoa River; thence bounded towards the east generally by the sea and the Napier Electoral District boundary hereinbefore described to the confluence of the Old Ngaruroro River and Ngaruroro River ; thence by the said Old Ngaruroro River to its intersection with the railway-line; thence bounded towards the south generally by the said railway-line to and along the north-eastern, south-eastern, south-western, and north-western boundaries of the Borough of Hasting to the Hastings-Fernhill Road, and by that road and the inland Patea Road, Glenross Road, to and along the road inter-secting the Kohurau Block, to and along the aforesaid Ngaruroro River to the Rotorua Electoral District boundary, the place of commencement.

WAIPAWA.

Walpawa District comprises the existing Walpawa Electoral District less the whole of the Norsewood Riding of Dannevirke County and that part of the Matamau Riding of the said Dannevirke County lying between the existing Walpawa Electoral District boundary and the north-eastern boundary of the said Matamau Riding of the satisfiest of the Takapau Riding of Waipawa County lying between the existing Waipawa Electoral District boundary and the road forming the southern boundary of Section 34, western bound-aries of Sections 37 and 1s, Block XVI, Ruataniwha Survey bistrict, and the railway-line from the south-western corner of the said Section 1s and the Marekeke Stream. This district now includes that portion of the existing Hawke's Bay Electoral District lying between the existing Waipawa Electoral District boundary and the Hawke's Bay Electoral District boundary hereinbefore described.

PAHIATUA.

Pahiatua District comprises the existing Pahiatua Electoral District less that portion of the Tararua Riding of Pahiatua County lying between the existing Pahiatua Electoral District boundary, and the north-eastern and south-eastern boundaries of the said Tararua Riding. This district now includes the Norsewood and that part of the Matamau Riding of Danne-virke County, together with that part of the Takapau Riding of Waipawa County now excluded from the Waipawa Electoral District hereinbefore described.

MASTERTON.

Masterton District comprises the existing Masterton Electoral District together with that portion of the Tararua Riding of Pahiatua County now excluded from the existing Pahiatua Electoral District hereinbefore described; also includes the North Riding of Castlepoint County and that portion of the West Riding of the said Castlepoint County lying between the existing Masterton Electoral District boundary and the southern and eastern boundaries of the said West Riding; also includes that portion of the Upper Taueru Riding of Masterton County lying between the existing Masterton Electoral District boundary and the southern and eastern boundaries of the said Upper Taueru Riding; also that portion of the Tewhiti Riding of the said Masterton County and the eastern boundary of the said riding and the northern boundary of the Wairarapa South County; also the whole of the Belvedere Riding of the said Wairarapa South County and that part of the Parkvale Riding of the aforesaid Wairarapa South County lying between the existing Masterton Electoral District boundary, the north-eastern side of Francis Road, the south-eastern side of Dorset Road, the north-eastern side of the road forming the south-western boundaries of Sections 1, 11, 32, and 110, Blocks XI and XV, Tiffin Survey District, and the Ruamahanga River. lying between the existing Masterton Electoral District

WAIRARAPA.

This district is bounded towards the north generally by the Masterton Electoral District hereinbefore described from the Masterton Electoral District hereinbefore described from the summit of the Tararua Range at Mount Hector to the sea at the southern boundary of the North Riding of the Castlepoint County; thence bounded towards the east and south generally by the sea to Turakirae Head; thence by the summit of the Rimutaka Range to the northern boundary of the Wainui-o-mata Riding of Hutt County; thence by the said northern boundary of the said Wainui-o-mata Riding and the southern and western boundaries of the Heretaurea Riding and the western boundary of the Murga-Heretaunga Riding and the western boundary of the Munga-roa Riding, all of the said Hutt County, to and along the northern boundary of the aforesaid Hutt County to the summit of the Tararua Range at Mount Hector, the place of commencement.

WAIMARINO.

Waimarino District comprises the existing Waimarino Electoral District less that portion of the Tahora Riding of Whangamomona County lying between the existing Waima-rino Electoral District boundary and the eastern boundary rino Electoral District boundary and the eastern boundary of the said Whangamomona County; also less that portion of the Pungapunga Riding of Taumarunui County and that portion of the Taupo County now included in the Rotorua Electoral District hereinbefore described. This district now includes those portions of Waimiha Riding of Taumarunui County and Matiere Riding of Ohura County excluded from the Waitomo Electoral District hereinbefore described; also includes the Borough of Taihape, together with that portion of the Erewhon Riding of Rangitikei County lying between the existing Waimarine Electoral District boundary between the existing Waimarino Electoria District boundary and the southern boundary of the said Erewhon Riding; also that portion of the Ruanui Riding of the said Rangitikei County lying between the existing Waimarino Electoral District boundary, the northern boundary of the Borough of Taihape, the southern boundary of the said Ruanui Riding, and the Main Trunk Railway line.

STRATFORD.

Stratford District comprises the existing Stratford Electoral District together with that portion of the Tahora Riding of Whangamomona County now excluded from the Waimarino Electoral District hereinbefore described, together with that portion of the Waitara West Riding of Taranaki County lying between the existing Stratford Electoral District boundary, the Borough of Waitara, and the railway-line from Waitara to Inglewood.

NEW PLYMOUTH.

New Plymouth District comprises the existing New Plymouth Electoral District less that portion of the Waitara West Riding of Taranaki County now included in the Stratford Electoral District hereinbefore described.

EGMONT.

Egmont District comprises the existing Egmont Electoral District, the boundaries of which are unaltered.

PATEA.

Patea District comprises the existing Patea Electoral District together with those portions of the Brunswick-Westmere Riding of Waitotara County lying between the existing Patea Electoral District boundary and the north-western boundary of the City of Wanganui.

Wanganui District is bounded on west, north, and east generally by the boundary of the City of Wanganui from the ocean at Castlecliff, to and along the Turoa Road, to and along the Matarawa Road (No. 3 Line), to and along the left bank of the Wanganui River and the ocean to the western-most boundary of the said City of Wanganui at Castlecliff, the place of commencement the place of commencement.

RANGITIKEI.

Rangitikei District is bounded on the west, north, and east generally by the Wanganui, Patea, Waimarino, and Waipawa Electoral Districts boundaries from the mouth of the Wanganui River to the Ruahine Range at the southern boundary of Kiwitea County; thence by the said Kiwitea County bound-ary to and along the Oroua River, to and along Forlong's Road in the Western Riding of Oroua County; thence by Road in the Western Riding of Oroua County; thence by the Makino, Junction, and Stanway Roads to and along the road forming the northern boundary of Halcombe Township, to and along the Main Trunk Railway line, to and along the Rangitikei River to the ocean, and by the ocean to the mouth of the Wanganui River, the place of commencement.

PALMERSTON.

Palmerston District comprises the whole of the City of Palmerston North.

MANAWATU.

Manawatu District is bounded on the north and east generally by the Rangitikei, Waipawa, Pahiatua, and Master-ton Electoral Districts hereinbefore described from the ocean ton Electoral Districts hereinbefore described from the ocean at the mouth of the Rangitikei River to the summit of the Taraua Range at the southern boundary of Manawatu County; thence bounded towards the south generally by the southern boundary of the said Manawatu County, to and along the southern, eastern, and northern boundaries of the Borough of Foxton, to and along the Foxton–Sanson Railway line, to and along the northern boundary of the Awahou Riding of the aforesaid Manawatu County to the ocean; thence bounded towards the west by the ocean to the mouth of the Rangitikei River, the place of commence-ment, excluding the Palmerston Electoral District herein-before described.

OTAKI.

Otaki District is bounded towards the north and east generally by the Manawatu, Masterton, and Wairarapa Electoral Districts hereinbefore described from the ocean at Electoral Districts hereinbefore described from the ocean at the northern boundary of the Awahou Riding of Manawatu County to the summit of the Tararua Range at Mount Hector; thence by the northern boundary of the Hutt County, to and along the western boundaries of the Mungaroa, Heretaunga, and Epuni Ridings of the said Hutt County, to and along the eastern boundary of Makara County, to and along the eastern boundary of Section 27, north-eastern and north-western boundaries of Section 7, all of Block VIII, Belmont Survey District, to and along the Takapu Road, to and along the eastern and northern boundaries of the Tawa Riding and northern boundary of the Ohariu Ridine, all Riding and northern boundary of the Ohariu Riding, all of the said Makara County, to the ocean; thence bounded towards the west by the ocean to the northern boundary of the Awahou Riding of Manawatu County, the place of com-mencement, including Mana, Kapiti, and adjacent islands.

WELLINGTON NORTH.

Wellington North comprises the existing Wellington North Electoral District less that portion of Wellington City lying between the existing Wellington North Electoral District boundary and the southern side of Webb Street. This district now includes that portion of Wellington City lying between the existing Wellington North Electoral District boundary, the eastern side of Sefton Street, the southern side of Wadestown Road, western side of Watt Street, southern side of Baker Street and its production to Wellington Harbour: side of Baker Street and its production to Wellington Harbour; also includes that portion of Wellington City lying between the existing Wellington North Electoral District boundary, the eastern side of Fairlie Terrace, the eastern side of Kelburn Parade, the eastern side of Salamanca Road, and the south-Parade, the eastern side of Salamanca Road, and the south-eastern side of Bolton Street; also that portion of Wellington City lying between the existing Wellington North Electoral District boundary, the northern side of Webb Street, the western side of Taranaki Street, the northern side of Buckle Street, the western side of Tory Street, the northern side of Cable Street, and the western side of Barnett Street. This district now includes Somes Island.

Wellington Central.

Wellington Central comprises the existing Wellington Central Electoral District less that portion of Wellington City lying to the west of Tory Street now included in the Wellington North Electoral District hereinbefore described ; also less that portion of Wellington City lying between the existing Wellington Central Electoral District boundary, the southern side of Bidwell Street, and western side of Wallace Street. This district now includes that portion of Wellington City lying between the existing Wellington Central Electoral District boundary, the northern side of Tapiri Street, north-western side of Hamilton Road, north-eastern side of Overtoun Terrace, the north-eastern side of Belvedere Road, and the western shores of Evans Bay and the southern shores of Wellington Harbour.

WELLINGTON EAST.

Wellington East comprises the existing Wellington East Electoral District less that portion of Wellington City lying between the existing Wellington East Electoral District boundary, the northern side of Tapiri Street, the northwestern side of Hamilton Road, the north-eastern side of Overtoun Terrace, and the north-eastern side of Belvedere Road now included in the Wellington Central Electoral District hereinbefore described.

Wellington South.

Wellington South comprises the existing Wellington South Electoral District together with that portion of Wellington City lying between the existing Wellington South Electoral District boundary, the southern side of Bidwell Street, and the western side of Wallace Street now excluded from the Wellington Central Electoral District hereinbefore described.

Wellington West.

Wellington West is bounded on the north generally by the northern boundary of the Makara Riding of Makara County from the sea to the western boundary of Wellington City; thence bounded towards the east generally by the western boundary of the said Wellington City, to and along the Kaiwarawara Stream, to and along the north-eastern boundary of Section 2, Kaiwarra, to the Wellington North Electoral District boundary; thence by that boundary and the western boundaries of the Wellington Central and Wellington South Electoral Districts hereinbefore described to Cook Strait; thence bounded towards the south and west generally by the sea to the northern boundary of the said Makara Riding, the place of commencement.

HUTT.

Hutt District is bounded on the west, north, and east generally by the Wellington–Wairarapa Railway line from the Main Hutt Road railway-crossing to Melling Road; thence by that road to and along Brunswick Street, to and along Kings Crescent, to and along Pretoria Street, to and along the Hutt Borough boundary, to and along Witako Street, to and along Waterloo Road, to and along Cambridge Terrace, to and along White's Line, to and along the eastern and southern boundaries of the said Hutt Borough to Port Nicholson Harbour; thence bounded towards the south by the shores of the said Port Nicholson Harbour to a point in line with the Main Hutt Road railway-crossing; thence by the road to the Wellington–Wairarapa Railway line, the place of commencement, including Gear Island.

Wellington Suburbs.

Wellington Suburbs District is bounded by the Otaki, Wairarapa, and Hutt Electoral Districts hereinbefore described from the ocean at the northern boundary of the Ohariu Riding of Makara County to Port Nicholson at a point in line with the Main Hutt Road railway-crossing ; thence by the shores of the said Port Nicholson and Wellington Harbour to the Wellington North Electoral District boundary hereinbefore described ; thence by that boundary and the Wellington West Electoral District boundary of the Makara Riding of Makara County ; thence by the ocean to the northern boundary of Ohariu Riding, the place of commencement.

WESTLAND District comprises the existing Westland Electoral District less the whole of the Red Jack, Nelson Creek, and Waipuna Ridings, all of the Grey County. This district now includes the whole of the Boatman's Riding of the aforesaid Inangahua County; also includes the whole of the Waipuna, Nelson Creek, and Red Jack Ridings of the Grey County now included in the Westland Electoral District hereinbefore described; also includes the whole of the Karamea Riding of Buller County and that portion of the Mokihinui Riding of the said Buller County lying between the existing Buller Electoral District boundary and the northern boundary of the said Mokihinui Riding.

MOTUEKA.

Motueka District comprises the existing Motueka Electoral District less the whole of the Boatman's Riding of Inangahua County ; also less the whole of the Karamea Riding of Buller County and that portion of the Mokihinui Riding of the said Buller County now included in the Buller Electoral District hereinbefore described ; also less that portion of the Wai-iti Riding of Waimea County lying to the south of the existing Motueka Electoral District boundary ; also less that portion of the Stoke Riding of the said Waimea County lying to the south of the existing Motueka Electoral District boundary ; also less that portion of the Motupiko Riding of the aforesaid Waimea County bounded towards the north-east generally by the existing Motueka Electoral District boundary from the north-east corner of Section 34, Block X, Wai-iti Survey District, to and along the Nelson-Tadmor Railway line to the eastern boundary of the said Motupiko Riding ; thence bounded towards the east generally by the said eastern boundary of the aforesaid Motupiko Riding ; thence bounded towards the onthe-maty of the south by the north-east corner of Block XI, Gordon Survey District ; thence bounded towards the south by the northern boundary of the said Block XI, Gordon Survey District ; thence bounded towards the south by the northern boundary of the Golden Downs Settlement ; thence bounded towards the west generally by the said road to and along the nord forming the eastern boundary of Section 1 of Small Grazing-run 12, Block VI, Gordon Survey District, and by the continuation of the said road across the Nelson-Glenhope Railway line, to and along the road forming the eastern boundaries of Small Grazing-run 10, Sections 22 and 27, all of Block II, Gordon Survey District; thence by the eastern boundaries of Sections 41, 32, 33, and 34 of Block XIV, Wai-iti Survey District, and the western boundaries of Sections 4 and 6, Block X, Wai-iti Survey District; thence bounded towards the north by the northern boundaries of the said Section 6, Block X, Wai-iti Survey District, and Section 34 of Block X, Wai-iti Survey District, and Section 34 of Block X, Wai-iti Survey District, to the existing Motueka Electoral District boundary at the north-eastern corner of the said Section 34 of Block X, Wai-iti Survey District; also less that portion of the Appleby Riding of the aforesaid Waimea County lying between the existing Motueka Electoral District boundary and the north-western boundary of the said Appleby Riding. This district now includes those portions of Antonio's and Crushington Ridings of Inangahua County now excluded from the Buller Electoral District hereinbefore described.

NELSON.

Nelson District comprises the existing Nelson Electoral District less that portion of the Pelorus-Havelock Riding of the Marlborough County lying between the existing Nelson Electoral District boundary and the north-western, northern, and north-eastern boundaries of the said Pelorus-Havelock Riding; also less that portion of the Sounds County lying between the existing Nelson Electoral District boundary, the south-western boundary of the Said Sounds County, the south-eastern boundary of the Croixelles Road District, and the south-eastern boundary of the French Pass Road District. This district now includes those portions of the Wai-iti, Stoke, Motupiko, and Appleby Ridings of Waimea County now excluded from the Motueka Electoral District hereinbefore described.

WAIRAU.

Wairau District comprises the existing Wairau Electoral District together with that portion of the Pelorus-Havelock Riding of the Marlborough County and that portion of the Sounds County now excluded from the Nelson Electoral District hereinbefore described.

HURUNUI.

Hurunui District comprises the existing Hurunui Electoral District the boundaries of which are unaltered.

CHRISTCHURCH NORTH.

Christchurch North comprises the existing Christchurch City lying between the existing Christchurch City lying between the existing Christchurch North Electoral District boundary and North Avon Road; also less that part of Christchurch City lying between the existing Christchurch North Electoral District boundary, the south-western side of Victoria Street, and the southern side of Bealy Avenue. This district now includes that part of Christchurch City lying between MoFadden's Road, Rutland Street, and the city boundary; also includes that portion of the Fendalton Riding of the Waimairi County lying between the existing Christchurch North Electoral District boundary, the northern side of the Avon River, the eastern side of the railwayline, and the southern side of the Wairarapa Stream.

CHRISTCHURCH SOUTH.

Christchurch South comprises the existing Christchurch South Electoral District less that portion of Christchurch City lying between the existing Christchurch South Electoral District boundary and Colombo Street. This district now includes that portion of Christchurch City lying to the south of Bealy Avenue and south-west of Victoria Street now excluded from the Christchurch North Electoral District hereinbefore described.

CHRISTCHURCH EAST.

Christchurch East comprises the existing Christchurch East Electoral District together with that portion of Christchurch City lying between the Christchurch East Electoral District boundary and Colombo Street now excluded from the Christchurch South Electoral District hereinbefore described; also includes that portion of Christchurch City lying between the existing Christchurch East Electoral boundary, the southern side of Tuam Street, and the western side of Matheson's Road.

Avon District comprises the existing Avon Electoral District less that part of Christchurch City lying between the existing Avon Electoral District boundary, the southern side of Tuam Street, and the western side of Matheson's Road now included in the Christchurch East Electoral District hereinbefore described. This district now includes that portion of Christchurch City lying between the existing Avon Electoral District boundary and the southern and eastern sides of North Avon Road now excluded from the Christchurch North Electoral District hereinbefore described.

RICCARTON.

Riccarton District comprises the existing Riccarton Electoral District less that part of the Fendalton Riding of Waimairi County lying between the existing Riccarton Electoral District boundary, the northern side of the Avon River, the eastern side of the railway-line, and the southern side of the Wairarapa Stream now included in the Christchurch North Electoral District hereinbefore described; also less the whole of the Kinloch Riding of the Wairewa County; also less that portion of the Springston Riding of the Springs County lying between the existing Riccarton Electoral District boundary and Swamp Road, the road forming the north-western boundaries of Sections 4050 and 4032, Block VII, Leeston Survey District, and Selwyn Road.

KAIAPOI.

Kaiapoi District comprises the existing Kaiapoi Electoral District less that portion of the City of Christchurch lying between McFaddens Road, Rutland Street, and the city boundary now included in the Christchurch North Electoral District hereinbefore described. This district now includes that portion of the Springston Riding of Springs County excluded from the Riccarton Electoral District hereinbefore described.

LYTTELTON.

Lyttelton District comprises the existing Lyttelton Electoral District together with the whole of the Kinloch Riding of Wairewa County now excluded from the Riccarton Electoral District hereinbefore described.

MID-CANTERBURY.

This district comprises the existing Mid-Canterbury Electoral District, the boundaries of which are unaltered.

TEMUKA.

This district comprises the existing Temuka Electoral District together with that portion of the Seadown Riding of the Levels County bounded towards the east by the sea, towards the south generally by Hedley's Road, to and along Seadown Road, to and along the road forming the southern boundary of Section 1 of Milford Settlement, Block VI, Arowhenua Survey District, across the Christchurch-Dunedin Railway line, to and along the road forming the southern boundaries of Sections 14574, R. 1362 and 21370, Block VI, Arowhenua Survey District, Sections 20966, 20817, 22161, 20816, and 21034, Block V, Arowhenua Survey District, to and along Foley's Road, to and along Point Temuka Road, to and along the continuation of Kerry Town Road to the Opihi River; thence bounded towards the north by the said Opihi River to the sea.

TIMARU.

This district comprises the existing Timaru Electoral District less that part of the Seadown Riding of the Levels County now included in the Temuka Electoral District hereinbefore described.

WAITARI,

This district comprises the existing Waitaki Electoral District together with that part of the Papakaio Riding of the Waitaki County bounded towards the north by the existing Waitaki Electoral District boundary, to the southeast by the sea, and to the south by the road forming the northern boundaries of Sections 201, 95, 94, 93, 92, 91, 90, 89, 88, and 87, Block II, Papakaio Survey District, to and along the Christchurch-Dunedin Railway line, to and along Peebles Road from the eastern boundary of Section 112 of the said Block II, Papakaio Survey District, to the north-western corner of Section 104, Block III, Papakaio Survey District; thence by the Horse Gully Road, to and along the eastern and northern boundaries of the Waiareka Riding of Waitaki County, to and along the Big Hill Road to Teaneraki, to and along the road to St. Helens Settlement, and the road forming the western boundary of Sections 25 and 26, Block XIV, Oamaru Survey District, to and along the southern and western boundaries of the Waiareka Riding of the aforesaid Waitaki County to the existing Waitaki Electoral District boundary.

OAMARU.

Oamaru District comprises the existing Oamaru Electoral District less those portions of the Waiareka and Papakaio Ridings of Waitaki County now included in the Waitaki Electoral District hereinbefore described. This district now includes the whole of the Blueskin Riding of Waikouaiti County, also that part of the Merton Riding of the said Waikouaiti County lying between the existing Oamaru Electoral District boundary, the southern and western boundaries of the said Merton Riding, and the sea.

DUNEDIN NORTH.

Dunedin North comprises the existing Dunedin North Electoral District together with the Borough of Port Chalmers, and that portion of the North-east Valley Riding of the Waikouaiti County not included in the existing Dunedin North Electoral District; also that portion of the Dunedin City lying between the existing Dunedin North Electoral District boundary, Chapman Street, Shetland Street, and Mount Street; also includes Quarantine and Quail Islands.

DUNEDIN WEST.

DUNEDIN CENTRAL.

Dunedin Central Electoral District is bounded on the north. east, and south generally by the Dunedin West Electoral District hereinbefore described from the southern boundary of Block IX, Dunedin and East Taieri Survey District, to of Block IX, Dunedin and East Taieri Survey District, to the Otago Harbour; thence by the southern shores of the said Otago Harbour and ocean to a point in line with Prince Albert Road; thence by the said Prince Albert Road and King Edward Street, to and along the railway-line, to and along South Road, to and along Playfair Street, to and along the Southern boundary of St. Andrews, Caversham, and Caversham Extension, to and along Sidey Street, to and along Corstorphine Road, to and along the Dunedin City boundary to the southern boundary of Block IX, Dunedin and East Taieri Survey District, the place of commencement.

DUNEDIN SOUTH.

Clutha District comprises the existing Clutha Electoral District together with the whole of the Waipori Riding of Tuapeka County, also the Borough of Lawrence and that portion of Gabriels Riding of the said Tuapeka County lying between the existing Clutha Electoral District boundary, the Tuapeka River, the southern boundary of Run 494, Block XVIII, Tuapeka East Survey District, the northern boundaries of Blocks XIX and X of the said Tuapeka East Survey District, the western and southern boundaries of Section 51, southern boundaries of Sections 8, 34, 58, 57, and 56, all of the aforesaid Block X of the aforesaid Tuapeka East Survey District. MATAURA.

Mataura District comprises the existing Mataura Electoral District together with that part of the Hokanui Riding of the Southland County lying between the existing Mataura Electoral District boundary and the Otamita Stream. Wallace District comprises the existing Wallace Electoral District less that part of the Waimatuku Riding of the Wallace County now included in the Awarua Electoral District hereinbefore described; also less the Borough of Riverton; also less that portion of the Hokanui Riding of Southland County now included in the Mataura Electoral District hereinbefore described. This district now includes that portion of the Winton Riding of the said Southland County now excluded from the Awarua Electoral District hereinbefore described; also includes the whole of the Greenstone and Kingston Ridings of the Lake County, the Borough of Queenstown, and that portion of the Queenstown Riding of the said Lake County lying to the south of the range forming the northern watershed of the Moonlight Creek to its junction with the Shotover River, the right line running from the said junction to the summit of the Coronet, and the line running due east from the summit of the said Coronet to the Coronet Creek.

CENTRAL OTAGO. This district is bounded towards the north-west generally by the south-eastern boundary of the Westland Electoral District hereinbefore described from the north-eastern corner of the Greenstone Riding of Lake County to the northernmost corner of the Vincent County; thence bounded towards the north-east generally by the south-western boundaries of the Waitaki, Oamaru, and Dunedin North Electoral Districts hereinbefore described to the south-eastern corner of the Deep Stream Riding of Taieri County; thence bounded towards the south-west generally by the north-eastern boundary of the Dunedin South Electoral District hereinbefore described to the sea at the north-eastern corner of Block VIII, Waihola Survey District; thence bounded the coast to the mouth of the Taieri River; thence bounded towards the south generally by the northern boundaries of the Clutha, Mataura, and Wallace Electoral Districts herein-before described to the southernmost corner of the Kingston Riding of the said Lake County; thence bounded towards the west generally by the eastern boundary of the said Wallace Electoral District to the north-eastern corner of the said Greenstone Riding.
