IN pursuance and exercise of the powers conferred by the Public Works Act, 1928, and of all other powers in anywise enabling him in this behalf, His Excellency the Governor-General of the Dominion of New Zealand, acting by and with the advice and consent of the Executive Council of the said Dominion, doth hereby approve of the following resolution passed by the Kaitangata Borough Council on the fourth day of November, one thousand nine hundred and thirty-six, viz. :—

“The Kaitangata Borough Council, being the local authority having control of the streets in the Borough of Kaitangata, by resolution declares that the provisions of section one hundred and twenty-eight of the Public Works Act, 1928, shall not apply to that portion of the street adjoining the northern boundary of Allotment 1, plan number 2344, North Molyneux District” ;

subject to the condition that no building or part of a building shall at any time be erected on the land fronting the southern side of the portion of street (described in the Schedule hereto) within a distance of thirty-three feet from the centre-line of the said portion of street.

subject to the condition that no building or part of a building shall at any time be erected on the land fronting the southern side of the portion of road (described in the Schedule hereto) within a distance of thirty-three feet from the centre-line of the said portion of road.
