

*Changing the Purpose of the Reservation over Portion of the Omaka Domain.*

ORDER IN COUNCIL.

At the Government House at Wellington, this 27th day of January, 1937.

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL.

WHEREAS a notice of intention to issue an Order in Council declaring that the portion of the Omaka Domain, described in the Schedule hereto, shall cease to be subject to Part II of the Public Reserves, Domains, and National Parks Act, 1928, and shall be deemed to be a public reserve for a site for an aerodrome subject to Part I of the said Act, was published in the *Gazette* of the twenty-fourth day of September, one thousand nine hundred and thirty-six :

And whereas such notice of intention was duly laid before both Houses of Parliament in accordance with the provisions of subsection two of section seven of the Public Reserves, Domains, and National Parks Act, 1928 :

And whereas the Legislative Council and the House of Representatives, by resolutions dated respectively the twenty-eighth and twenty-ninth days of October, one thousand nine hundred and thirty-six, approved the proposed change of purpose as aforesaid :

Now, therefore, His Excellency the Governor-General of the Dominion of New Zealand, in pursuance and exercise of the powers and authorities conferred by subsection one of section forty-one of the Public Reserves, Domains, and National Parks Act, 1928, and acting by and with the advice and consent of the Executive Council of the said Dominion, doth hereby declare that from and after the day of the date hereof the portion of the Omaka Domain, described in the Schedule hereto, shall cease to be subject to Part II of the said Act, and shall be a public reserve for a site for an aerodrome subject to Part I of the said Act.

SCHEDULE.

MARLBOROUGH LAND DISTRICT.—PORTION OF OMAKA DOMAIN.
