“That the Dunedin City Council, being the local authority having control of the streets in the City of Dunedin, by resolution declares that the provisions of section one hundred and twenty-eight of the Public Works Act, 1928, shall not apply to the north-western side of portion of Wales Street abutting on Allotment 11, Township of Bishopscourt, being also part of Section 5, Block III, Upper Kaikorai District” ;

subject to the condition that no building or part of a building shall at any time be erected on the land fronting the north-western side of the portion of Wales Street (described in the Schedule hereto), within a distance of thirty-three feet from the centre-line of the said portion of street.

IN pursuance and exercise of the powers conferred by the Public Works Act, 1928, and of all other powers in anywise enabling him in this behalf, His Excellency the Governor-General of the Dominion of New Zealand, acting by and with the advice and consent of the Executive Council of the said Dominion, doth hereby approve of the following resolutions passed by the Dunedin City Council on the thirtieth day of August and the eleventh day of October, one thousand nine hundred and thirty-seven, respectively, viz. :—

(1) “That the Dunedin City Council, being the local authority having control of the streets in the City of Dunedin, by resolution declares that the provisions of section one hundred and twenty-eight of the Public Works Act, 1928, shall not apply to the south-western side of portion of Shetland Street abutting on parts of Lots 51 and 53, Township of Anderston” ;

(2) “That the Dunedin City Council, being the local authority having control of the streets in the City of Dunedin, by resolution declares that the provisions of section one hundred and twenty-eight of the Public Works Act, 1928, shall not apply to the north-eastern side of portion of Shetland Street abutting on Lots 24, 26, 28, and part Lot 30, Township of Anderston, being part Section 104, Wakari Survey District” ;

subject to the condition that no building or part of a building shall at any time be erected on the land fronting the south-western and north-eastern sides of the portions of Shetland Street (described in the Schedule hereto) within a distance of thirty-three feet from the centre-lines of the said portions of street.
