RESOLUTION MAKING SPECIAL RATE.

Motueka Borough Conversion Loan, 1935.

IN pursuance and exercise of powers vested in it in that behalf of Part II of the Local Authorities Interest Reduction and Loans Conversion Act, 1932-33, and the Motueka Borough Loans Conversion Order, the Motueka Borough Council hereby resolves as follows:—
