A PROCLAMATION.

IN pursuance and exercise of the powers and authorities vested in me by the Public Works Act, 1928, and of every other power and authority in anywise enabling me in this behalf, I, George Vere Arundell, Viscount Galway, Governor-General of the Dominion of New Zealand, do hereby revoke the Proclamation dated the twentieth day of June, one thousand nine hundred and sixteen, and published in the *New Zealand Gazette* No. 69 of the twenty-second day of the same month at page 1996, taking land for the purposes of a wharf and road access thereto in Block II, Muriwhenua Survey District, in so far as it affects the area of 1 acre taken for the purposes of a wharf.
