**B**Y virtue and in exercise of the powers and authorities conferred upon me by section eighteen of the Forests Act, 1921-22, I, George Vere Arundell, Viscount Galway, Governor-General of the Dominion of New Zealand, do hereby set apart the Crown land described in the Schedule hereto as a permanent State forest.

## SCHEDULE.

## TARANAKI LAND DISTRICT.—WELLINGTON FOREST-CONSERVATION REGION.

ALL that area in the Taranaki Land District containing by admeasurement 462 acres, more or less, being part of Section 11, Block V, Aria Survey District, and bounded generally as follows: Towards the east by Sections 2 and 12, Block V aforesaid; towards the south-east by a State forest (*Gazette* 1933, page 1215); towards the west by Mokau-Mohakaitino 1H Block; and towards the north-west by Subdivision 1 of the said Section 11, and by Section 10, Block V, aforesaid. As the same is more particularly delineated on plan No. 52/5, deposited in the Head Office of the State Forest Service, at Wellington, and thereon bordered red.
