(3) The said respective loans or any parts thereof, together with interest thereon, shall be repaid by equal aggregate annual or half-yearly instalments extending over the respective terms as determined in (1) above.
(4) The payment of such instalments shall be made in New Zealand, and no such instalment shall be paid out of loan.

Authorizing the Borrowing by the Riccarton Borough Council by Way of Hypothecation of Debentures issued in respect of a Loan of \$2,800.

HIS EXCELLENCY THE GOVERNOR-GENERAL IN COUNCIL.

WHEREAS by Order in Council made on the fifteenth day of December, one thousand nine hundred and W day of December, one thousand nine hundred and thirty-seven, consent was given to the raising in New Zealand by the Riccarton Borough Council (hereinafter called "the said local authority") of the sum of two thousand eight hundred pounds (£2,800) by a loan to be known as "North-west Area Improvement Repayment Loan, 1937" (herein-after called "the said loan"), such consent being given subject to the determinations as to borrowing and repayment therein set out, including, *inter alia*, the provision that the rate of interest that might be paid in respect of the said loan or any part thereof should be such as should not produce to the lender or lenders a rate or rates exceeding three pounds ten shillings (£3 10s.) per centum per annum : shillings (£3 10s.) per centum per annum : And whereas by Order in Council made on the twenty-third

day of March, one thousand nine hundred and thirty-eight, the said determinations were varied to prescribe that the term for which the said loan may be raised shall be ten (10) years

in lieu of twenty (20) years : And whereas the said local authority, pending the raising of the said loan in accordance with the said determinations as varied, is desirous of borrowing the amount or part thereof

by hypothecation or mortgage pursuant to section thirty-four of the Local Bodies' Loans Act, 1926, of the debentures authorized to be issued in respect of the said loan :

Now, therefore, His Excellency the Governor-General of the Dominion of New Zealand, acting by and with the advice and consent of the Executive Council of the said Dominion, and in pursuance and exercise of the powers and authorities conferred on him by section seven of the Local Authorities Interest Reduction and Loans Conversion Act, 1932–33, and by section eight of the Local Authorities Interest Reduction and Loans Conversion Amendment Act, 1933, and of all other powers and authorities enabling him in this behalf, doth hereby consent to the said local authority, pending the raising of the said loan in accordance with the said determinations as varied, borrowing the said sum of two thousand eight hundred pounds $(\pounds 2,800)$ or any part thereof by the hypothecation or mortgage of the said debentures at a rate hypothecation or mortgage of the said debentures at a rate of interest not exceeding four pounds ten shillings (£4 10s.) per centum per annum, and hereby prescribes that the said local authority shall before the said sum of two thousand eight hundred pounds (£2,800) or any portion thereof is borrowed by way of hypothecation pursuant to the authority of this Order in Council, establish a sinking fund and shall thereafter make payments to such sinking fund in accordance with the terms of clause three of the aforesaid Order in Council of the fifteenth day of December, one thousand nine hundred and thirty-seven, and in all respects as if such borrowing of the said sum of two thousand eight hundred pounds (£2,800) or any part thereof by way of hypothecation were the raising of a loan within the meaning of that clause.
