IN pursuance and exercise of the powers conferred by section twelve of the Land Act, 1924, I, George Vere Arundell, Viscount Galway, Governor-General of the Dominion of New Zealand, do hereby proclaim as road the land in Rewa Survey District described in the First Schedule hereto; and also do hereby proclaim as closed the road described in the Second Schedule hereto.

## FIRST SCHEDULE.

LAND PROCLAIMED AS ROAD.

APPROXIMATE area of the piece of land proclaimed as road: 1 acre 0 roods 1.4 perches. Being portion of Lot 1, D.P. 2218, and being part Sections 75

and 621, Whareama Block; coloured red.

## SECOND SCHEDULE.

ROAD CLOSED.

APPROXIMATE area of the piece of road closed: 1 acre 0 roods 8.8 perches.

Adjoining or passing through Lot 1, D.P. 2218, being part Sections 75 and 621, Whareama Block; coloured green.
