WHEREAS the land described in the Schedule hereto is a Y reserve duly set apart for a site for a public library:
And whereas it is expedient that the control of the said reserve should be vested in a special Board as hereinafter provided:

Now, therefore, His Excellency the Governor-General of the Dominion of New Zealand, acting by and with the advice and consent of the Executive Council of the said Dominion, and in exercise of the powers and authorities conferred upon him by section seventeen of the Public Reserves, Domains, and National Parks Act, 1928, doth hereby vest the control of the reserve described in the Schedule hereto, for the period of five years from the date hereof (unless previously amended or revoked under the said Act), in the undermentioned persons, namely:

William Philip Boyd, William Patrick O'Connor, Patrick Joseph Keenan, William Henry Knowles, and Samuel Hyndman,

who are hereby constituted for that purpose a special Board by the name of the Rimu Public Library Board (hereinafter referred to as "the Board"), with the powers and subject to the conditions hereinafter contained, that is to say:—

1. The Board shall meet for the transaction of business on the third Monday in each month at eight o'clock p.m., at the Rimu Public Library, or at such other time or place as may from time to time be fixed by the Board. The first meeting shall be held on Monday, the sixteenth day of May, one thousand nine hundred and thirty-eight.

2. The members of the Board shall, at their first meeting

and thereafter at the annual meeting hereinafter mentioned, elect one of themselves to be Chairman, who may join in the discussion, and shall have an original as well as a casting vote. The Chairman shall hold office until the election of
