GALWAY, Governor-General. [L.S.] A PROCLAMATION.

WHEREAS it has been found desirable for the use, con-V venience, and enjoyment of the Kaipara-Waikato Railway to take further land at Pokeno in addition to land previously acquired for the purposes of the said railway, and to take land for road-diversion in connection therewith :

Now, therefore, I, George Vere Arundell, Viscount Galway, Governor-General of the Dominion of New Zealand, in exercise of the powers and authorities conferred on me by sections thirty-four and two hundred and sixteen of the Public Works Act, 1928, and of every other power and authority in anywise enabling me in this behalf, do hereby proclaim and declare that the land described in the Schedule hereto is hereby taken for the purposes above mentioned.

#### GALWAY, Governor-General. [L.S.] A PROCLAMATION.

IN pursuance and exercise of the power and authority vested in me by the Births and Deaths Registration Act, 1924, I, George Vere Arundell, Viscount Galway, Governor-General of the Dominion of New Zealand, do hereby Governor-General of the Dominion of New Zealand, do hereby abolish the existing registration districts known as the Rangiriri and Thames districts, and do proclaim and declare that the territory heretofore comprised within the said districts is hereby divided anew into two registration districts the names whereof shall be the Rangiriri and Thames districts, and the boundaries whereof shall be conterminous with the boundaries of the marriage districts bearing the same names as are set forth in a Proclamation of even date-herewith, made under the provisions of the Marriage Act. 1908:

## A PROCLAMATION.

IN pursuance and exercise of the power and authority vested in me by the Marriage Act, 1908, I, George Vere Arundell, Viscount Galway, Governor-General of the Dominion of New Zealand, do hereby abolish the existing marriage districts known as the Rangiriri and Thames districts, and do proclaim and declare that the territory heretofore comprised within the said districts is hereby divided anew two marriage districts, the names and boundaries whereof into shall be as follows :-

#### RANGIRIRI DISTRICT.

ALL that area in the Auckland Land District bounded towards the north by a right line, being the production in a westerly direction of the southern boundary-line of Section No. 106, Whangape Parish, in Block XIII, Onewhero Survey District,
