“The Riccarton Borough Council, being the local authority having control of the streets in the Borough of Riccarton, by resolution declares that the provisions of section one hundred and twenty-eight of the Public Works Act, 1928, shall not apply to that portion of street known as Straven Terrace, adjoining land in Lot 296, D.P. 4530”;

subject to the condition that no building or part of a building shall at any time be erected on the land fronting the northern side of the portion of Straven Terrace (described in the Schedule hereto) within a distance of thirty-three feet from the centre-line of the said portion of street.
