“(a) The south-eastern side of portion of Douglas Terrace abutting on Allotment 10 and parts of Allotments 9 and 11, Block I, Township of Dalkeith;

“(b) The south-western side of portion of Montague Street abutting on parts of Allotments 9 and 14, Block I, Township of Dalkeith”;

subject to the condition that no building or part of a building shall at any time be erected on the land fronting the south-eastern side of the portion of Douglas Terrace or the south-western side of the portion of Montague Street (described in the Schedule hereto), within a distance of thirty-three feet from the centre-lines of the said portions of streets.

#### SCHEDULE.

THE south-eastern side of all that portion of street, situated in the Otago Land District, City of Dunedin, known as Douglas Terrace, fronting Allotment 10 and parts Allotments 9 and 11, Block I, Township of Dalkeith.

Also the south-western side of all that portion of street in the said land district and city known as Montague Street, fronting parts Allotments 9 and 14, Block I, Township of Dalkeith.
