Provincial Districts established by that section shall be those set out in the Schedule hereto under the names of the respective Provincial Districts

SCHEDULE.

AUCKLAND PROVINCIAL DISTRICT.

ALL that area bounded towards the west, north, east, and and that are bounded towards the west, north, east, and north-east generally by the sea from the mouth of the Awakino River to the westernmost corner of Matakaoa County; thence towards the east and south-east generally by the counties of Matakaoa, Waiapu, Waikohu, and Wairoa to the

 39° parallel of latitude; thence towards the south by the 39° parallel of latitude to Ohura River; thence by the Ohura River to the southern boundary of Ohura County; thence by the southern and western boundaries of Ohura County to the Mokau River; thence by the Mokau River to the Ngatarawa Road; thence by that road to the Awakino River and by the Awakino River to the sea, the place of commencement, and including all boroughs and town districts situated therein, and all adjacent islands.

EAST COAST PROVINCIAL DISTRICT.
