25s.
- (3) Serially as issued and annual bound volume, as in (1)
and (2) above, on combined subscription basis,
42s. per annum in advance.
- (4) Separate regulations as issued.
- (5) Loose-leaf binder for filing serial issues, 6s. 6d.

The price of each regulation will be printed thereon faci-
litating the purchase of extra copies.

Orders on the subscription basis should be placed now with
the Government Printer, Wellington, or at the Chief Post
Offices at Auckland, Christchurch, or Dunedin.
