The Shops and Offices Act, 1921-22, and its Amendments.-Fixing the Closing-hours of Grocers' Shops within the Combined District of Nelson.

Authorizing the Laying-off of Roads of less Width than 66 ft.

WHEREAS in the opinion of the Minister of Lands it is inexpedient by reason of the fact that the land shown upon the plan of Town of Shirley Extension No. 19, affecting parts of Rural Sections 557 and 231, situated in Block XII, Christchurch Survey District, is intended to be used wholly for residential purposes, that Achilles Street, Ajax Street, and Rowe Place shown thereon should be of the width of 65.54.
