THE RIGHT HON. P. FRASER PRESIDING IN COUNCIL.

WHEREAS the Southland Hospital Board (hereinafter called "the said local authority"), being desirous of raising a loan of twenty thousand pounds (£20,000), to be known as "Dee Street Hospital Building Loan, 1942" (hereinafter called "the said loan"), for the purpose of building additions to and renovating Dee Street Hospital, including hot-water service, electrical installation, sterilizer installation, and refurnishing, has complied with the provisions of the Local Government Loans Board Act, 1926 (hereinafter called "the said Act"), and it is expedient that the precedent consent of the Governor-General in Council, as required by the said Act, should be given to the raising of the said loan:

Now, therefore, His Excellency the Governor-General of the Dominion of New Zealand, acting by and with the advice and consent of the Executive Council of the said Dominion, and in pursuance and exercise of the powers and authorities conferred on him by section eleven of the said Act, as set out in section twentynine of the Finance Act, 1932 (No. 2), and of all other powers and authorities enabling him in this behalf, doth hereby consent to the raising in New Zealand by the said local authority of the said loan for the said purpose up to the amount of twenty thousand pounds (£20,000), and in giving such consent doth hereby determine as follows:—

- (1) The term for which the said loan or any part thereof may be raised shall not exceed twenty (20) years.
- (2) The rate of interest that may be paid in respect of the said loan or any part thereof shall be such as shall not produce to the lender or lenders a rate or rates exceeding three pounds twelve shillings and sixpence (£3 12s. 6d.) per centum per annum.
- (3) The said loan or any part thereof, together with interest thereon, shall be repaid by equal aggregate annual or half-yearly instalments extending over the term as determined in (1) above.
- (4) The payment of such instalments shall be made in New Zealand, and no instalments shall be paid out of loan-moneys.
- (5) The rate payable for brokerage, underwriting, and procura-tion fees in respect of the raising of the said loan or any part thereof shall not in the aggregate exceed one-half per centum of any amount raised.
- (6) No moneys shall be borrowed under this consent after the expiration of two years from the date hereof.

5. (1) Every such committee may meet at such times and places as it thinks fit and may adjourn any meeting, and in the absence of the chairman may appoint some member present to be chairman of the meeting.

(2) No business shall be transacted at any meeting of a committee unless a quorum is present.

(3) All questions coming before a committee at any meeting shall be decided by a majority of the votes of the members present thereat, and, in the case of an equality of votes, the chairman shall beare a casting vote. have a casting vote.

#### TRAVELLING ALLOWANCES AND EXPENSES.

Out of the Board's funds there may be paid or refunded to any member in respect of his attendance at any meeting of a to any member in respect of his attendance at any meeting of a committee, or in respect of his performance of any business or work authorized by the Board or a committee to be done or performed, the same costs and expenses as he would be entitled to be paid or have refunded, in accordance with the provisions of Regulation 38 of the principal regulations, for his attendance at a meeting of the Board.
