1. So much of the Warrant under section 3 of the Motor Vehicles Amendment Act 1936, dated the 23rd day of November 1938,\* as relates to part of the Auckland-Hamilton State Highway No. 7 referred to in the said Warrant as the Great South Road in Huntly Borough is hereby revoked.

2. The portions of road specified in the First Schedule to this notice are hereby excluded from the limitation as to speed imposed by section 36 of the Transport Act 1949.
