Pursuant to section 128 of the Public Works Act 1928, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby approves of the resolution passed by the New Plymouth City Council on the 16th day of December 1957 and set out in the First Schedule hereto, in so far as it affects the sides and portions of streets described in the Second Schedule hereto.

FIRST SCHEDULE

"THE New Plymouth City Council, being the local authority having control of the streets in the City of New Plymouth, by resolution declares that the provisions of section 128 of the Public Works Act 1928 shall not apply:

(a) To the western side of the portion of Brougham Street adjoining part B and Sub.
