## NOTICE OF INTENTION TO TAKE LAND

## BLENHEIM BOROUGH COUNCIL

## RESOLUTION MAKING SPECIAL RATE

*Waterworks Loan 1953, £100,000—Second Portion of £10,000*

IN pursuance and exercise of the powers vested in it in that behalf by the Local Authorities Loans Act 1956, and all other powers enabling it in that behalf, the Blenheim Borough Council doth hereby resolve as follows:

"That, for the purpose of securing the interest and other charges on a loan of ten thousand pounds (£10,000) being the second portion of the Waterworks Loan 1953, £100,000 authorised to be raised by the Blenheim Borough Council under the above-mentioned Act for the purpose of renewing the spiral steel mains of the borough water supply reticulation system and for providing for works and expenses incidental thereto, the said Council hereby makes and levies a special rate of forty-seven one-thousandths of a penny (0.047d.) in the pound (£) on the unimproved rateable value of all rateable property within the Borough of Blenheim as existed prior to the extension of its boundaries on 1 April 1952; and that such special rate shall be an annually recurring rate payable on demand in each and every year during the currency of the said loan, being a period of thirty (30) years, or until the said loan is fully paid off, and the said Council doth hereby appropriate and pledge the said special rate as security for the above loan."
