NOTICE OF INTENTION TO TAKE LAND

In the matter of the Municipal Corporations Act 1954 and the Public Works Act 1928

NOTICE is hereby given that the Timaru City Council proposes, under the provisions of the above-mentioned Acts, to execute a certain public work, namely, the widening of the street known as The Terrace in the City of Timaru, and for the purpose of such public work the lands described in the Schedule hereto are required to be taken; and notice is hereby further given that a plan of the lands so required to be taken is deposited in the public office of the Town Clerk to the said Council, situated in King George's Place, Timaru, and is open for inspection, without fee, by all persons during ordinary office hours.

All persons affected by the execution of the said public work or by the taking of such lands who have any well-grounded objections to the execution of the said public work or to the taking of the said lands must state their objections in writing and send the same, within 40 days from the first publication of this notice, to the Town Clerk at the Council Chambers, King George's Place, Timaru.

TOWN AND COUNTRY PLANNING ACT 1953

Dunedin Metropolitan Regional Planning Scheme, Amendment No. 1, 1962

PURSUANT to the Town and Country Planning Regulations 1960, public notice is hereby given that the Dunedin Metropolitan Regional Planning Scheme, Amendment No. 1, 1962, has been approved in accordance with the provisions of section 10 of the Town and Country Planning Act 1953 and amendments, and shall become operative on 13 September 1962.

The amendment alters the zoning of an area of land containing 15 acres, more or less, in the Borough of Green Island, adjacent to Brighton Road, from "Industrial" to "Residential", as shown on map reg. 7/A.
