

*Declaring Portion of Mount Cook National Park to be Excluded from the Provisions of the Tourist Hotel Corporation Act 1955*

HIS EXCELLENCY THE ADMINISTRATOR OF THE GOVERNMENT IN COUNCIL

PURSUANT to section 11 of the Tourist Hotel Corporation Act 1955, His Excellency the Administrator of the Government acting by and with the advice and consent of the Executive Council, hereby declares that the lands described in the Schedule hereto, being portion of Mount Cook National Park, shall as from the date hereof cease to be administered by the Tourist Hotel Corporation of New Zealand for the purposes of the said Act, but otherwise shall remain part of the said park.

SCHEDULE

CANTERBURY LAND DISTRICT

ALL that area containing 157 acres, more or less, being part Reserve 2652, situated in Blocks X and XIV, Mueller Survey District, and bounded as follows: Commencing at a point on the north bank of Black Birch Stream in line with the north-eastern boundary of Rural Section 34350; thence north-westerly generally to and along that boundary to the northernmost corner of the said rural section; thence by right lines bearing  $282^{\circ} 20'$ , 1,186.8 links, and  $327^{\circ} 20'$ , 2,350 links, to the south bank of Kitchener Creek; thence easterly generally along the south bank of that creek, to and south-easterly along the western side of a watercourse to Black Birch Stream; thence south-westerly generally along the northern bank of Black Birch Stream to the point of commencement; excepting thereout the portion of Main Highway 217 and legal roads within the above boundaries.

As shown on the plan marked T.H.C./03 deposited in the Head Office of the Tourist Hotel Corporation of New Zealand at Wellington, and thereon edged red, the said areas being numbered 9 on the said plan (S.O. Plan 8661). Portion of Mount Cook National Park.
