PURSUANT to section 186 of the Municipal Corporations Act 1954, and section 125 of the Public Works Act 1928, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby authorises the Christchurch City Council to permit the laying off of the proposed street described in the Schedule hereto at a width for part of its length of less than 66 ft, but not less than 40 ft, subject to the condition that no building or part of a building shall at any time be erected on the land edged green on the plan referred to in the said Schedule as M.O.W. 6743 within a distance of 35 ft from the centre line of such proposed street.
