ORDER

1. On and from the 1st day of April 1964 the area described in the Schedule hereto is hereby excluded from the County of Stratford and included in the County of Inglewood.

2. The alteration of the boundaries of the said counties hereinbefore made shall be deemed to have been effected under the Counties Act 1956.

SCHEDULE

ALL that area in the Taranaki Land District containing 1,380 acres, more or less, bounded by a line commencing at a point in the middle of the Waitara River in line with the north-eastern boundary of Section 18, Block V, Ngatimaru Survey District, and proceeding generally north-westerly along a right line to and along the north-eastern boundary of that section to the western boundary of Section 19, Block V, aforesaid; thence generally northerly along the western boundary of that section to Pita Road; thence across that road and easterly generally along its northern side to the westernmost corner of Section 14, Block 1, Ngatimaru Survey District; thence generally easterly along the southern boundary of Sections 14 and 13, Block 1, aforesaid, to the southernmost point of the last-mentioned section; thence by a right line direct to the middle of the Waitara River, thence southerly and westerly generally down the middle of that river to the point of commencement.
