Rural Housing Loan No. 11, 1968—\$80,000

PURSUANT to the Local Authorities Loans Act 1956, the Raglan County Council hereby resolves as follows:

"That, for the purpose of providing the annual charges on a loan of \$80,000 authorised to be raised by the Raglan County Council under the above-mentioned Act for the purpose of making advances to farmers in terms of the Rural Housing Act 1939, the said Raglan County Council hereby makes a special rate of decimal nought six five four of a cent (.0654c) in the dollar (\$) upon the unimproved value of all rateable property comprising the whole of the County of Raglan; and that the special rate shall be an annually recurring rate during the currency of the loan and be paid yearly on the 1st day of September in each and every year during the currency of such loan, being a period of twenty (20) years or until the loan is paid off."
