(2) At least three of the councillors shall be resident within the subdistrict comprising the regions including and adjoining Kawakawa and Moerewa; at least two of the councillors shall be resident within the subdistrict comprising the regions including and adjoining Kawakawa and Moerewa; at least two of the councillors shall be resident within the subdistrict comprision including and adjoining Kawakawa and Moerewa; at least two of the the region including and adjoining Kaikohe; at least one shall be resident within the subdistrict comprising the region including and adjoining Ohaeawai; at least one shall be resident within the subdistrict comprising the region including and adjoining Okaihau; at least one shall be resident within and adjoining Okaihau; at least one shall be resident within the subdistrict comprising the region including and adjoining Kerikeri; at least one shall be resident within the subdistrict comprising the region including and adjoining Russell; at least one councillor shall be resident within the subdistrict of Ruapekapeka, Towai, Maromaku; at least three councillors shall be resident within the subdistrict comprising the least three councillors.

Hokianga County. The remaining nine councillors may reside in any part of the district.

(3) The President shall, so long as he continues to be a member of the Society, hold office for a term of 3 years. He shall be eligible for re-election, subject to his term of office as councillor not having expired; or, if that term of office has expired, subject to his re-election as councillor by ballot of the general morphorship.

(4) The Vice-President shall, so long as he continues to be a member of the Society, hold office for 1 year. He shall be eligible for re-election, subject to his term of office as councillor not having expired; or, if that term of office has expired, subject to his re-election as a councillor by ballot of the general membership.

(5) In those years when the term of office of the President expires, immediately following upon the declaration of the result of the election of members of the Council the President shall vacate office and an elected Chairman shall call for nominations for the office of President. Nominations shall be

confined to members of the newly elected Council.

(6) Each year when the term of office of Vice-President expires, immediately following upon the declaring the result of the election of members of the Council the Chairman shall call for nominations for the office of Vice-President. Such nominations shall be confined to members of the newly elected Council.

(7) In the event of only one nomination for each office of President and Vice-President, the Chairman shall declare each nominee duly elected to office but if there be more than one nomination for either office a secret ballot of members present at the meeting shall be taken.

(8) (a) At the annual general meeting held in 1971 seven councillors, including one from Hokianga, shall retire, but shall be eligible for re-election. The councillors may agree among themselves as to who shall retire, but failing agreement

(b) At the annual general meeting held in 1972, seven of the councillors who did not retire in 1971, including one from Hokianga, shall retire, but shall be eligible for reelection. The councillors may agree among themselves as to who shall retire, but failing agreement the matter shall be determined by lot

(c) At each subsequent general meeting the councillors who have been longest on the Council without being reelected shall retire, but shall be eligible for re-election. The vacancies created under this subclause of this rule shall be filled by ballot as provided in rule 10 hereof.

(9) Vacancies on the Council caused by the retirement of members shall be filled from such members as will maintain the subdistrict representation as set out in subclause (2) of this rule

(10) Where any member of the Council ceases to have his permanent and principal or only place of residence within the district, he shall cease to be a member of the Council from the commencement of the next annual general meeting.

(11) In the event of any member of the Council dying, resigning, or vacating his office, the Council may appoint to the vacancy any member of the Society who is available and eligible. Such appointee shall hold office for the balance of the term of his predecessor. Any such appointment shall maintain the proportional or district representation as set out in subclause (2) of this rule.

(12) A member of the Council shall vacate his office if he has absented himself from three consecutive meetings of the Council without leave of absorbed himself.

Council without leave of absence having been granted by the Council.

(13) An elected member or a member appointed to fill a vacancy under subclause (11) of this rule shall vacate his office if he ceases to be a member of the Society.

(f) For "Seconds", 80 points or over but under 88 points, the price of 13.24c per pound.
2. In the appropriate cases the following amounts shall be added to or deducted from the prices fixed in paragraph 1 hereof where cheese has been classified by the Department of hereof where cheese has been classified by the Department of Agriculture in respect of cheese sediment test:

Classification A—an addition of 0.10c per pound; Classification B—no alteration; Classification C—a deduction of 0.05c per pound; Classification D—a deduction of 0.10c per pound.

3. Cheese shall be packed in fibreboard cartons each containing a net weight of 60 lb 3 oz of actual cheese, excluding

4. In computing the weight of rindless cheese for which payment is to be made by the Board, the weight of all cheese comprised in any consignment submitted for grading under the said regulations shall be ascertained as follows:

(a) Each carton of cheese containing a net weight of 60 lb 3 oz of actual cheese, excluding wrapping, shall, subject as hereinafter provided, be computed at 60 lb;

(b) The weight of all cheese in any such consignment shall be determined on the basis of the weight as ascertained by the grader of the several cartons selected by him for weighing and set out in the Grader's Certificate issued in respect of that consignment, and the cartons of cheese so weighted shall be taken as fiving the average weight for the whole taken as fixing the average weight for the whole quantity of cheese comprised in such certificate, overweights being averaged with underweights in each such certificate in relation to the prescribed

weight of 60 lb 3 oz per carton;

(c) If the average weight, ascertained as aforesaid, of the cheese comprised in any Grader's Certificate be less than 60 lb 3 oz per carton, such deficiency shall be deducted from a weight of 60 lb per carton for the

purpose of computing payment therefor;

(d) If the average weight, ascertained as aforesaid, of the cheese comprised in any Grader's Certificate exceeds the prescribed weight of 60 lb 3 oz per carton, then the amount of such excess shall not be taken into account for the purpose of computing payment therefor

5. The prices fixed by the Board shall not be paid for any cheese manufactured otherwise than in compliance with

the said regulations.

6. The price to be paid by the Board for any cheese which, with the approval or at the request of the Board, is manufactured, prepared, or packed in special containers, or in special quantities, or otherwise in any special manner, shall be the appropriate price payable for that cheese as hereinbefore provided, adjusted by such appropriate addition or reduction as corresponds with the additional costs or the reduced costs incurred in such special manufacture, preparation, or packing. Any such approval or request of the Board reduced costs incurred in such special manufacture, preparation, or packing. Any such approval or request of the Board may include a stipulation limiting the additional cost to be incurred and may dispense with the requirements of paragraphs 3 and 4 hereof, and, in that event, payment shall be made for the actual net weight of the cheese exported. The adjustment to prices referred to in this paragraph shall be computed by the Board and the computation of the Board shall be final.

7. The prices set out in paragraph 1, Gazette notice No. 39, 3 July 1969, p. 1224, are amended accordingly.

Electrical Wiring Regulations 1961—Electrical Apparatus Which May Constitute an Electrical Hazard

PURSUANT to regulation 8 of the Electrical Wiring Regulations 1961, notice is hereby given that:

1. The apparatus described below may, in my opinion, constitute an electrical hazard:

Description: Three-pin flat-pin type plug constructed from moulded thermo-setting material in conjunction with a rubber grommet and a circular terminal cover of resin bonded sheet attached by the use of three screws. The moulded portion is marked-

and the earth pin marked

2. The possible electrical hazard arises from the omission of provisions to prevent the internal connections making dangerous contact in the event of a broken or loose conductor or screw, and also from the omission of adequate cord anchorage for the flexible cord to relieve strain, including twisting, on the conductors where they are connected to the terminals.

Both these conditions have been the cause of fatal electrical

accidents in New Zealand.

3. The plugs fail to comply with the electrical safety requirements of New Zealand Standard Specification 198:1967 -3-pin flat-pin plugs, plug-sockets, tapons, and cord extension sockets with 10 amp, 250 volt (maximum) rating, in respect of the following clauses of the specification—

Clause 1--Scope (current rating) Clause 5—Dimension of pins
Clause 9—Internal connections
Clause 11—Identification of pins Clause 15—Cord anchorage

Compliance with the electrical safety requirements of NZSS 198 is a statutory requirement for this type of plug.

- 4. These plugs are likely to be connected to the flexible cord of sewing machines and other appliances manufactured
- 5. All persons who have purchased appliances fitted with the above-mentioned plugs should arrange for the plugs to be immediately replaced with ones of a safe type complying with NZSS 198:1967, and destroy the unsafe ones.
- 6. Every person who sells or offers for sale any apparatus which, in the opinion of the General Manager, New Zealand Electricity Department, constitutes or may constitute an electrical hazard commits an offence and shall be liable to a fine not exceeding \$200.

The "normal" refers to the present site of the instruments. The standard periods for normals are: for temperature 1931-60, for rainfall 1921-50, and for sunshine 1935-60. No normals are available for stations with only short records.

Notes on the Weather for February 1970

General—February was a dry month over the greater part of the country. In western districts of the North Island rainfall had been inadequate back to October 1969 and in some of these areas even further back. Farmers reported serious drought conditions in the main dairying areas of the North Island, with some herds of cows drying off and winter silage already being fed to others. Sheep were also short of feed and starting to lose condition. Forest fires were reported in many areas. However, conditions proved suitable for harvesting. The main farming areas not affected to the day were the results of the main farming areas. by the dry weather were Gisborne and most of Hawke's Bay; and Southland and Otago with parts of Canterbury.

Rainfall—In the North Island rainfall was mainly only a quarter of the normal value, but it was close to zero in parts of Taihape and Manawatu; Kapiti Island received only 0.01 in. However, in Gisborne and parts of Hawke's Bay it was wetter than usual, with totals up to three times the average and exceeding 15 in. in places

In the South Island rainfall was mainly half the normal value. The deficiency there was greatest in Marlborough, where a station near Seddon received only 0.06 in. Rainfall was above average in Fiordland and western Southland besides parts of inland South Canterbury.

For the first 2 months of the year the total rainfall was unusually low in many North Island districts. At Hamilton, with 1.18 in., it was the lowest since 1946; and at Palmerston North, with 1.43 in., it was the lowest since 1928

In northern Hawke's Bay and Gisborne totals of as much as 8 in. were recorded for the 2 days 10 and 11 February, causing serious flooding in Wairoa.

Temperatures—Temperatures were mainly close to, or somewhat above, normal. However, in central and southern Hawke's Bay they were 2 degrees cooler than usual.

The month was marked by an unusually high frequency of south-easterly winds, especially up to the 17th, making this the cooler part of the month.

Sunshine—Sunshine was above normal by 30-70 hours in northern and some western districts of the North Island, besides Nelson and Marlborough with the greater part of Canterbury; and in coastal Southland. Motueka received 287 hours.

Sunshine was below normal by 30-60 hours in Gisborne, with eastern Bay of Plenty and most of Hawke's Bay. Napier received only 161 hours.

Weather Sequence—At the beginning of February a belt of high pressure extended from the south Tasman Sea across the South Island to the Chatham Islands, while a depression was centred off East Cape. Easterly to south-easterly winds prevailed, especially over the North Island, with light rain in Gisborne and northern Hawke's Bay, besides some other east coast areas of both Islands. During the 2nd and 3rd the depression moved somewhat closer to Gisborne and a cold front crossed the country. Conditions remained rather similar.

Pressures increased over the North Island with the advance of an anticyclone, but in the south the westerlies freshened with the approach of a trough of low pressure. On the 4th some rain was reported in Bay of Plenty and Coromandel, besides Fiordland. During the next 2 days the trough became almost stationary over the South Island, with rain spreading to Westland, Southland, and Otago. On the 7th and 8th the trough crossed the remainder of the country, producing a change to southerly winds. Rain was fairly general but mainly light.

A depression soon developed to the north-east of Auckland and remained there from the 9th to the 11th. In the easterlies rain developed in Gisborne and Northland and spread to Hawke's Bay, with some heavy falls, causing flooding in Wairoa. On the following day the depression moved away and the rain became lighter. Another trough of low pressure caused freshening southerlies on the 13th, with light rain also spreading to some eastern districts of the South Island. For the next 2 days an anticyclone was centred to the south-east of the South Island, while pressures remained low to the north. Easterlies brought some scattered light rain to the northern half of the North Island. From the 16th to the 18th the weather was fine.
Westerlies freshened in the south during the 19th and 20th, with

a trough of low pressure moving on to the South Island as a very deep depression passed close to Macquarie Island. Rain spread over the West Coast, western Southland, and parts of Otago, with some heavy falls in Fiordland. During the following day the trough crossed the country, affecting mainly the South Island, except for Nelson, Marlborough, and North Canterbury. From the 22nd to the 24th a belt of high pressure brought mainly fine weather. However, in the westerlies over the South Island, Fiordland, and South Westland received some rain. Pressures remained high on the 25th and 26th, but light rain was reported in Bay of Plenty and eastern Northland.

During the last 2 days of the month a small depression passed close to Southland and the associated trough of low pressure crossed the country. Rain was fairly general but mainly light; exceptions were western Northland, Nelson, and the West Coast.
