A PROCLAMATION

A PROCLAMATION

PURSUANT to section 4 of the Public Works Amendment Act 1947, I, Sir Arthur Espie Porritt, Baronet, the Governor-General of New Zealand, hereby proclaim and declare that

the middle line of a further portion of the Wellington-Foxton Motorway shall be that defined and set forth in the Schedule hereto, and I also declare that this Proclamation shall affect only the lands situated within the limits of the area shown edged red on the plan marked M.O.W. 25911 (sheets 1 to 4), referred to in the said Schedule.
