## *State Forest Land Set Apart as State Forest Park*

A PROCLAMATION

PURSUANT to section 63B (1) of the Forests Act 1949 (as substituted by section 19 of the Forest Amendment Act 1976) I, Sir Edward Denis Blundell, the Governor-General of New Zealand, hereby set apart the State forest land described in the Schedule hereto as State forest park which shall hereby form part of the Craigieburn State Forest Park.

CANTERBURY LAND DISTRICT—CANTERBURY CONSERVANCY—MALVERN COUNTY

RURAL Section 40555, situated in Blocks V and IX, Grasmere Survey District; area, 57.9020 hectares, more or less (S.O. Plan 13735).

Rural Section 40556, situated in Block XII, Harper Survey District and Block IX, Grasmere Survey District; area, 148.3140 hectares, more or less (S.O. Plan 13735).
