(vi) A charge of 50c per copy of every copy after the fourth for each certificate issued.

For each additional animal the property of the same owner and examined at the same time: \$3.

(c) Fish and crayfish:
(i) For each original certificate covering whole consignment: \$15.

 (ii) When separate certificates are required for each package, cask, or parcel included in any one consignment, a fee of \$1.50 shall be payable for each 10 or portion of 10 such certificates.
