*Standard Grade for the Export of Citrus Notice 1982  
(No. 2891, Ag. 12/2/14)*

PURSUANT to regulation 13 of the New Zealand Grown Fruit and Vegetables Regulations 1975\*, the Director-General of Agriculture and Fisheries hereby gives notice that the standard grade for the export of citrus shall be as set out in this notice.

## NOTICE

## 1. Title—

- (1) This notice may be cited as the Standard Grade for the Export of Citrus Notice 1982
- (2) This notice shall come into force on the day after the date of its notification in the *Gazette*.

## 2. Application of Notice—

- (a) This notice determines the standard grade applicable for the export of citrus and shall be the minimum grade standard for citrus exported from New Zealand.
- (b) The uniformity of sizing requirements as set out in 8A-D shall apply only to citrus exported to those countries listed in the Third Schedule of this notice.

3. Title and Grade—The grade mark assigned to this standard grade shall be Class I (hereinafter referred to as "the grade").
