*Bylaw Fixing the Maximum Speed of Vehicles on State Highway No. 1 Over the Auckland Harbour Bridge*

PURSUANT to the National Roads Act 1953, the Auckland Harbour Bridge Authority Dissolution Act 1983 and the Transport Act 1962, the National Roads Board makes the following bylaw.

BYLAW

1. This Bylaw may be cited as the National Roads Board Bylaw 1987/2.

2. This Bylaw shall come into force on the 26th day of February 1987.

3. In this Bylaw "Vehicle" has the meaning assigned to it in the Transport Act 1962.

4. No person shall drive or take or permit to be driven or taken any vehicle upon or over that part of State Highway No. 1 (Awanui to Invercargill) being the Auckland Harbour Bridge and approaches from Route Position northbound 326/6.8 km to Route Position 326/3.7 km and Route Position southbound 326/3.5 km to Route Position 326/6.8 km from Onepoto Stream Bridge to Shelly Beach ramps at a speed in excess of 80 km/h.

5. Every person who commits an offence against this Bylaw is liable on summary conviction to a fine not exceeding five hundred dollars (\$500).

6. This Bylaw revokes any earlier bylaw setting speed restrictions on the Auckland Harbour Bridge for that section of State Highway No. 1 specified in clause 4 hereof.

This Bylaw was made by resolution duly passed at a meeting of the National Roads Board held in Wellington on the 18th day of February 1987.
