Pursuant to section 4 of the Military Decorations and Distinctive Badges Act 1918, His Excellency the Governor-General, acting by and with the advice and consent of the Executive Council, hereby makes the following order.

#### Order

- 1. Title—This order may be cited as the Returned Services Associations Badge Order 1987, Amendment No. 1, and shall be read together with and deemed part of the Returned Services Associations Badge Order 1987\* (hereinafter referred to as the principal order).
- **2.** Amendments to Second Schedule—(1) The Second Schedule to the principal order is hereby amended by inserting, after the item relating to the Ashhurst Returned Services Association, the following item:
  - "Auckland Returned Services Association (Incorporated)".
- (2) The Second Schedule to the principal order is hereby further amended by inserting, after the item relating to the Eltham Returned Services Association, the following item:
  - "Featherston Returned Services Association (Incorporated)".
- (3) The Second Schedule to the principal order is hereby further amended by inserting, after the item relating to the Te Awamutu Returned Services Association, the following item:
  - "Te Kauwhata Returned Services Association (Incorporated)".
- (4) The Second Schedule to the principal order is hereby further amended by inserting, after the item relating to the Waimate Returned Services Association, the following item:
  - "Wainuiomata Returned Services Association (Incorporated)".

## Education Act 1964

#### The Taranaki Polytechnic Notice 1988

Pursuant to section 69 of the Education Act 1964, the Minister of Education gives the following notice.

#### Notice

- 1. (1) This notice may be cited as the Taranaki Polytechnic Notice 1988.
- (2) This notice shall come into force on the date of its publication in the *Gazette*.
- 2. There shall be a board of governors, to be known as the Council of the Taranaki Polytechnic, which shall control the Taranaki Polytechnic.
- 3. The council of the Taranaki Polytechnic shall be constituted as follows:
- (a) Two members elected by the governing bodies of secondary schools in the provincial district of Taranaki, one to represent the governing bodies of Inglewood and Waitara secondary schools and all secondary schools within the New Plymouth city boundary and one to represent the governing bodies of all other secondary schools in the provincial district of Taranaki including the Taranaki Education Board.
- (b) Two members appointed by the Taranaki Local Bodies Association.
- (c) Two members elected by the associations of employers in local industries situated within the provincial district of Taranaki.
- (d) Two members elected by the associations of employees in local industries situated within the provincial district of Taranaki.
- (e) One member appointed by the Federated Farmers of New Zealand (Inc.) (Taranaki provincial district).
- (f) One member elected by the Taranaki Branch of the New Zealand Society of Accountants and the Taranaki Branch of the New Zealand Institute of Management.

- (g) One member appointed by the Taranaki Branch of the New Zealand Institution of Engineers.
  - (h) The Director-General of Education or his nominee.
- (i) One member who shall be the principal of the Taranaki Polytechnic.
- (j) One member who shall represent the staff of the Taranaki Polytechnic, and who shall be elected by the full-time employees of the council, and who shall be employed by the council.
- (k) One member to represent health services interests who shall be elected by various health services representatives on the Polytechnic Nursing Advisory Committee.
- (I) One member who shall represent Maori people in Taranaki and who shall be appointed by the Taranaki Maori Trust Board.
- (m) One member who shall represent the students of the Taranaki Polytechnic and who shall be appointed to a term of office of 1 year by the executive committee of the Polytechnic Students' Association.
- (n) Not more than three members may be co-opted by the council itself, if and when it thinks fit.
- 4. (1) Subject to the provisions of this clause and the provisions of paragraph (k) of clause 3 of this notice, the members of the council of the Taranaki Polytechnic shall hold office for a term of 3 years, but may, from time to time, be reappointed or re-elected.
- (2) Except in the case of a casual vacancy, every member shall hold office until the 31st day of May in the third year after the year of his appointment or election, and if, on the 31st day of May, the appointment or election of his successor has not been notified to the council he shall continue to hold office until the date on which that appointment or election is notified.
- (3) If any member dies, or resigns his office by writing under his hand addressed to the council or the chairman or the secretary thereof, or is absent without leave from the meetings of the council for 3 consecutive months, or while holding office becomes for any reason ineligible to remain a member, the casual vacancy so created shall be filled, as soon as practicable thereafter, by the appointment or election of a member in the manners in which the vacating member was appointed or elected, and the member appointed or elected to fill the vacancy shall hold office for the residue of the term of office of the member whom he replaces.
- (4) The powers of the council shall not be affected by any vacancy in the membership thereof.
- 5. The Taranaki Polytechnic Notice 1976 is hereby revoked.

# South Canterbury Electric Power Board Electricity Supply Licence 1988

I, David John Butcher, Minister of Energy, acting pursuant to section 20 of the Electricity Act 1968, hereby licence South Canterbury Electric Power Board, hereinafter called the Electrical Supply Authority, to supply electricity, and to lay, construct, put up, place and use all electric lines and works which may from time to time be required for the distribution and supply of electricity within the area specified in the Schedule hereto.

This licence is issued subject to the following conditions:

#### Conditions

- 1. This licence may be cited as the South Canterbury Electric Power Board Electricity Supply Licence 1988.
- 2. The Electrical Supply Authority shall comply with the provisions of this licence, the Electricity Act 1968 and all enactments made in amendment of or substitution for that Act, any Electrical Codes of Practice made under that Act, the Electrical Supply Regulations 1984, the Electrical Wiring Regulations 1976 and all regulations made in amendment of or substitution for any of those regulations.
- 3. Any notice to be given to the Electrical Supply Authority shall be sufficient if sent by registered post letter to the offices of the Electrical Supply Authority.
- 4. Any notice to be given on the part of the Minister of Energy shall be sufficient if given in writing signed by the Minister or by any persons acting under the authority of the Minister.
- 5. Any notice to be given to the Minister of Energy shall be sufficient if given in writing to or sent by registered post letter addressed to the Secretary of Energy, Ministry of Energy, Wellington.
- 6. This licence shall come into force on the 1st day of April 1988 and shall continue in force for a period of 21 years from that date unless it is sooner lawfully determined in accordance with clauses 7 or 8 hereof.
- 7. The Governor-General in Council may, pursuant to section 22 of the Electricity Act 1968, cancel this licence if the Electrical Supply Authority is in breach of the provisions contained in clause 2 of these conditions.
- 8. This licence may be cancelled by the Minister of Energy at the request of or with the consent of the Electrical Supply Authority.
- 9. At the expiry or cancellation of this licence, the Electrical Supply Authority shall, as required by notice in writing by the Minister of Energy, remove all buildings, poles and other erections and all transmission lines, plant and other machinery and other removable equipment authorised by the licence to be erected, installed or provided and if within 12 months after being so required the Electrical Supply Authority fails or neglects to remove the same, then the same shall, without payment of any compensation vest in and become the property of the Crown and it shall be lawful for any person authorised by the Minister of Energy in that behalf, subject to compliance with section 15A of the Electricity Act 1968 to enter upon any land or premises and take possession of and remove the same or any part thereof.
- 10. Nothing contained in the licence, either expressly or by implication shall be deemed to authorise the Electrical Supply Authority to erect, construct or maintain any lines or works except subject to such conditions (not inconsistent with this licence) as may from time to time be lawfully imposed by any

local authority within the district of which any such lines or works may be situated.

11. The systems of supply shall be as described in paragraphs (a), (b), (c), (d), (e), (f), (g), (h) and (j) of regulation 13 of the Electrical Supply Regulations 1984. The system of supply authorised under paragraph (j) shall be a single conductor earth-return system, and the use thereof shall be subject to such terms and conditions as are from time to time laid down by the Assistant Secretary (Industries and Markets), Ministry of Energy at Wellington.

12. The Electrical Supply Authority shall, 6 months prior to the expiry of the term of this licence provided in clause 6 herein, make written application to the Minister of Energy for the granting of a new licence.

## Waitemata Electric Power Board Electricity Supply Licence 1988

I, David John Butcher, Minister of Energy, acting pursuant to section 20 of the Electricity Act 1968 hereby licence Waitemata Electric Power Board hereinafter called the Electrical Supply Authority to supply electricity, and to lay, construct, put up, place and use all electric lines and works which may from time to time be required for the distribution and supply of electricity within the area specified in the Schedule hereto.

This licence is issued subject to the following conditions:

#### **Conditions**

1. This licence may be cited as the Waitemata Electric Power Board Electricity Supply Licence 1988.

- 2. The Electrical Supply Authority shall comply with the provisions of this licence, the Electricity Act 1968 and all enactments made in amendment of or substitution for that Act, any Electrical Codes of Practice made under that Act, the Electrical Supply Regulations 1984, the Electrical Wiring Regulations 1976 and all regulations made in amendment of or substitution for any of those regulations.
- 3. Any notice to be given to the Electrical Supply Authority shall be sufficient if sent by registered post letter to the offices of the Electrical Supply Authority.
- 4. Any notice to be given on the part of the Minister of Energy shall be sufficient if given in writing signed by the Minister or by any persons acting under the authority of the Minister.
- 5. Any notice to be given to the Minister of Energy shall be sufficient if given in writing to or sent by registered post letter addressed to the Secretary of Energy, Ministry of Energy, Wellington.
- 6. This licence shall come into force on the 1st day of April 1988 and shall continue in force for a period of 21 years from that date unless it is sooner lawfully determined in accordance with clauses 7 or 8 hereof.
- 7. The Governor-General in Council may pursuant to section 22 of the Electricity Act 1968 cancel this licence if the Electrical Supply Authority is in breach of the provisions contained in clause 2 of these conditions.
- 8. This licence may be cancelled by the Minister of Energy at the request of or with the consent of the Electrical Supply Authority.
- 9. At the expiry or cancellation of this licence, the Electrical Supply Authority shall as required by notice in writing by the Minister of Energy remove all buildings, poles and other erections and all transmission lines, plant and other machinery and other removable equipment authorised by the licence to be erected, installed or provided and if within 12 months after being so required the Electrical Supply Authority fails or neglects to remove the same, then the same shall, without payment of any compensation vest in and become the property of the Crown and it shall be lawful for any person authorised by the Minister of Energy in that behalf, subject to compliance with section 15A of the Electricity Act 1968 to enter upon any land or premises and take possession of and remove the same or any part thereof.
- 10. Nothing contained in the licence, either expressly or by implication shall be deemed to authorise the Electrical Supply Authority to erect, construct or maintain any lines or works except subject to such conditions (not inconsistent with this licence) as may from time to time be lawfully imposed by any local authority within the district of which any such lines or works may be situated.
- 11. The systems of supply shall be as described in paragraphs (a), (b), (c), (d), (e), (f) and (j) of regulation 13 of the Electrical Supply Regulations 1984. The system of supply authorised under paragraph (j) aforesaid shall be a single conductor earth-return system and the use thereof shall be subject to such terms and conditions as are from time to time laid down by the Assistant Secretary (Industries and Markets) of the Ministry of Energy at Wellington.
- 12. The Electrical Supply Authority shall, 6 months prior to the expiry of the term of this licence provided in clause 6 herein, make written application to the Minister of Energy for the granting of a new licence.

Notes to the Financial Statements Year Ended 30 September 1987

#### 1. Statement of Accounting Policies

#### General Accounting Policies

The financial statements are based on the general principles of historial cost accounting, including the going concern concept and the accrual basis of accounting.

#### Particular Accounting Policies

#### Consistency

The management fee paid to Westpac Banking Corporation was based on the direct costs associated with or apportionment in respect of Savings Bank activity. The accounting policy has been changed as it is considered more appropriate to only charge direct costs incurred.

Except for the above change there have been no significant changes in the accounting policies applied by the company during the period covered by these financial statements. All other policies have been applied on bases consistent with those used in previous years.

#### Valuation of Investments

New Zealand public securities are valued at cost adjusted annually for the proportion of discount or premium on purchase so as to allow redemption value by maturity date.

Whilst in the ordinary course of business some realisation of New Zealand public securities may take place at prices below book values, in the majority of cases these securities are held to, or close to maturity dates when they would be redeemed at face value. Accordingly, no provision is made for any difference between book value and market value of individual securities.

#### Sale of Public Securities

Profit or losses realised on sale of public securities are reflected in the profit and loss statement in equal annual instalments over the unexpired period to maturity of the securities sold or 5 years, whichever is the shorter.

#### Taxation

The company adopts tax effect accounting whereby income tax expense is calculated on pre-tax accounting profits after adjustment for permanent taxation differences. The tax effect of timing differences which occur where items are included or allowed for income tax purposes in a period different to that for accounting is shown in provision for deferred income tax and future income tax benefits, as applicable, at current taxation rates.

The liability method of inter-period allocation of income tax has been applied.
