# **Summary of Bills Introduced**

Government Superannuation Fund Amendment Bill (No. 3)

This bill amends the Government Superannuation Fund Act 1956 by implementing the report of the Higher Salaries Commission on superannuation provisions for existing members of Parliament.

Changes to current parliamentary superannuation provisions include the reduce rate of superannuation contribution, when a retiring member will become entitled to a retiring allowance, what the retiring allowance will be based on and the base for calculation of the retiring allowance.

#### Mutual Assistance in Criminal Matters Bill

This bill is designed to facilitate the provision and obtaining, by New Zealand, of international assistance in criminal matters. It gives effect to the Commonwealth Scheme Relating to Mutual Assistance in Criminal Matters, which was adopted at the Commonwealth Law Ministers' Meeting in Harare in 1986.

In particular, the bill provides an international dimension to the Proceeds of Crime Act 1991 in respect of the tracing, seizing, and confiscation of the proceeds and instruments of crime.

Forms of international co-operation in criminal matters provided for in the bill include:

- (a) The identification and location of persons;
- (b) The obtaining of evidence, documents, and other articles;
- (c) The production of documents and other articles;
- (d) The making of arrangement for persons to give evidence or assist in investigations;
- (e) The service of documents; and
- (f) The execution of requests for search and seizure.

#### Historic Places Bill

The bill amends and consolidates the Historic Places Act 1980. It deals principally with the registration system for historic places and the administration of that system. It includes new definition for "land" and "occupier". The New Zealand Historic Places Trust continues under this bill.

Part I of the bill provides for the protection of historic places through heritage orders, heritage convenants and archaeological sites.

The bill also provides for interim registration of historic places and historic areas for a period not exceeding 6 months. Interim registration protects places from intentional demolition, damage or modification. Local authorities also have to notify the Trust of any applications that would affect any registered historic place.

A Maori Heritage Council is proposed. It would consist of 6 members and its functions would include: ensuring that the Trust meets the needs of Maori; developing programmes for identifying and conserving waahi tapu areas; proposing the registration of waahi tapu areas; and advising the Trust on matters referred to it by the Trust.

The bill carries forward the offences presently set out in section 54 of the Historic Places Act 1980. The range of penalties in the bill is from \$2,500 to \$100,000. The bill empowers a Court to deprive an offender of rights under a resource consent or a district plan, for a period not exceeding 5 years.

#### Appropriation Bill (No. 5)

This bill is to issue and apply certain sums of public money for the year ending 30 June 1992, to authorise costs incurred, and to appropriate the supply granted for that year.

#### Imprest Supply Bill (No. 3)

This bill enables the issue and application of certain amounts of public money towards the service of the year ending with the 30th day of June 1992 and to authorise costs to be incurred towards the service of that year.

## **Income Tax Act 1976**

# Notice to Make Returns of Income Under the Income Tax Act 1976

Pursuant to the Income Tax Act 1976, the Commissioner of . Inland Revenue gives notice as follows:

(1) Returns of income for the year ended 31 March 1992 (or other approved balance date) are required from:

- (a) Every person who received income over \$20,000.
- (b) Every person who received income over \$9,500 which included income from employment and more than \$1,500 interest.
- (c) Every person who received income, from business, rents or any other income from which tax was not deducted.
- (d) Every person who received income from Withholding Payments.
- (e) Every person who received Guaranteed Retirement Income (National Superannuation) and their total other income was more than \$6,006.
- (f) Every person and, where applicable, the partner of that person within the meaning of section 374A of the Income Tax Act 1976, where either the person or the partner was issued with a Family Support Certificate of Entitlement under Part XIA of that Act.
- (g) Every person who received any income which did not have tax deducted at the correct rate as it was earned or received.
- (h) Every person who used a Special Tax Code IR 23, or the special shearers codes "SSH" or "SHR".
- (i) Every incorporated and unincorporated body which derived assessable income.
- (j) All companies, all partnerships, all persons in business (including farming) or in a profession, all persons in partnership, all trustees, executors and administrators, even if by reason of a loss being incurred for the year or carried forward from a previous year, no taxation is payable.

(2) Returns may be furnished by posting them to Inland Revenue, preferably to the processing centre where the client's records are held or by delivering them to the nearest Inland Revenue office.

(3) Due dates for furnishing returns of income for the year ended 31 March 1992.

- (1) In all cases where income has had tax deducted at the time it was earned for received (income from salary, wages, benefits, pensions, interest and dividends) and no other income whatsoever was derived, returns are due on the 7th day of June 1992. The return to use is the IR 5 (green print).
- (b) In all other cases, returns are due on the 7th day of July 1992, or within 2 months of balance date, whichever is the later.

The returns to be used are:

- IR 3 (dark blue print) for individuals.
- IR 4 (blue print) for companies.
- IR 6 (red print) for estates and trusts.
- IR 7 (brown print) for partnerships.
- IR 8 (gold print) for Maori authorities.

- IR 9 (olive print) for clubs and societies.

(4) Any person requiring a return form can obtain one from their local Inland Revenue office.

(5) Any person or company failing to furnish a return within the prescribed time is liable to a fine, when convicted, of:

- on the first occasion, not exceeding \$2,000 for each offence,
- on the second occasion, not exceeding \$4,000 for each offence,
- on every other occasion, not exceeding \$6,000 for each offence.

(6) Any person who is not required under paragraph (1) to furnish a return and who has derived income from employment may choose to furnish a return using form IR 5. A tax refund may arise, if for example:

- additional rebates or exemptions were not included in the tax code during the year; and or
- employment was only for part of the year.

# **Broadcasting Standards** Authority

## **Broadcasting Act 1989**

Broadcasting Standards Authority—Decision No. 6/92, 7/92, 8/92, 9/92, 10/92, 11/92, 12/92, 13/92, 14/92, 15/92 and 16/92

Pursuant to section 15 of the Broadcasting Act 1989, notice is hereby given that the Broadcasting Standards Authority has made the following decisions on complaints referred to it for investigation and review.

(i) In Decision 6/92, the Authority declined to uphold a complaint by the Society for Promotion of Community Standards that the broadcast by TV3 Network Services Limited of the documentary *Inside New Zealand* on 29 August 1991 breached the responsibilities placed on broadcasters to be truthful and accurate on points of fact, to show balance, impartiality and fairness in dealing with questions of a controversial nature and to avoid the use of any deceptive programme practice.

(ii) In Decision 7/92, the Authority declined to uphold a complaint by the Gisborne Boys' High School Board of Trustees that the broadcast by Radio 89FM of Gisborne, on 10 June 1991 breached the responsibility placed on broadcasters to maintain standards consistent with the privacy of the individual.

(iii) In Decision 8/92, the Authority upheld a complaint by Cook Islands Pearls Limited that the broadcast by TV3 Network Services Limited of an item on 60 Minutes on 7 July 1991 breached the responsibilities placed on broadcasters to deal justly and fairly with any person referred to, to show balance, impartiality and fairness in dealing with questions of a controversial nature, to take care in editing to ensure that overall views are not distorted and not to encourage the denigration of, or discrimination against, various groups. The Authority ordered TV3 Network Services Limited to publish a brief summary of the decision in the public notices column of the major Cook Islands newspaper by 1 April 1992.

(iv) In Decision 9/92, the Authority upheld a complaint by the Solicitor-General about action taken by Capital FM Limited after the broadcaster declined to consider a formal complaint in accordance with the requirements in the Broadcasting Act 1989.

(v) In Decision 10/92, the Authority declined to uphold a complaint by Mr R. Odinot of Eastbourne that the broadcast by Radio New Zealand Limited of an item on *Morning Report* on 10 October 1991 breached the responsibilities placed on broadcasters to maintain standards requiring good taste and decency, to deal justly and fairly with any person taking part in a programme and to show balance, impartiality and fairness in dealing with political matters.

(vi) In Decision 11/91, the Authority declined to uphold a complaint from Ms Rosalie Sugrue of Dunedin that the broadcast by Television New Zealand Limited of an item on *Frontline* on 18 August 1991 breached the responsibilities placed on broadcasters that when controversial issues of public importance are discussed, reasonable efforts are made or reasonable opportunities are given to present significant points of view, to deal justly and fairly with any person taking part in a programme, to show balance, impartiality and fairness in dealing with questions of a controversial nature, to take care in editing to ensure that views are not distorted and to present all

significant sides of a controversial public issue as fairly as possible.

(vii) In Decision 12/92, the Authority upheld a complaint from the Treasury that the broadcast by Television New Zealand Limited of an item on *Frontline* on 16 June 1991 breached the responsibility placed on broadcasters to deal fairly and justly with any person taking part in a programme.

(viii) In Decision 13/92, the Authority declined to uphold a complaint by Mr H. E. Jensen of Wellington that the broadcast by Radio New Zealand Limited of an item on *Morning Report* on 27 January 1992 breached the responsibility placed on broadcasters to maintain standards requiring good taste and decency.

(ix) In Decision 14/92, the Authority declined to uphold a complaint from Mr Robert Wardlaw of Auckland that the broadcast by Television New Zealand Limited of the programme *Birds of a Feather* on 12 November 1991 breached the responsibilities placed on broadcasters about taste and decency, about the protection of children and not to encourage the denigration of, or discrimination against, various groups.

(x) In Decision 15/92, the Authority upheld a complaint from the New Zealand Police that the broadcast by TV3 Network Services Limited of an item on 60 Minutes on 5 May 1991 breached the responsibility placed on broadcasters that when controversial issues of public importance are discussed, reasonable efforts are made or reasonable opportunities are given to present significant points of view. The Authority ordered TV3 Network Services Limited to broadcast a brief summary of the decision on a 60 Minutes programme before 15 May 1992.

(xi) In Decision 16/91, the Authority declined to uphold a complaint from Dr Nick Cooper of Auckland that the broadcast by TV3 Network Services Limited of an item on 60 Minutes on 13 October 1991 breached the responsibility placed on broadcasters to show balance, impartiality and fairness in dealing with a controversial matter.
